ORDER

Sri Md.Zainuddin Khan, R/o Hyderabad District filed 2nd appeal dated 16-09-2020 which was received by this Commission on 16-09-2020 for not getting the information sought by him from the PIO / O/o The Deputy Commissioner, Circle-17, GHMC. Central Zone, Khairtabad and 1st Appellate Authority / O/o The Deputy Commissioner, Circle-17, GHMC. Central Zone, Khairtabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **09-06-2020** under Sec.6(1) of the RTI Act, 2005, before the PIO seeking the following information:

Respected Sir,

Kindly furnish me the Certified Copies of the "Sanctioned Building Permission and Plan vide Permit No.53570/HO/CZ/Cir-10/2016, in File No.117826/25/02/2017/HO, issued on Dated.13-09-2019." over property bearing No.6-3-1218/6/2/1, admeasuring 4041 Sq.Yds in Survey No.199/2 Old No.199, Situated at Kundanbagh, Begumpet village, Khairatabad taluk, Hyderabad, T.S., to file the same before the Hon'ble XXV Addl Chief Judge, City Civil Court, in Pending Suit bearing No.O.S No.952 of 2014, and Before the Hon'ble High Court in W.P.No.20691 of 2015, wherein your respectable office is also one of the Respondent in the Pending Writ Pétition. Hence I Request you to issue me the abovesaid subject cited information as urgently as possible. Else I would suffer irreparable loss and grave injury and serious prejudice.

The Public Information Officer has not furnished the sought information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1st appeal dated **13-07-2020** before the 1st Appellate Authority requesting him to furnish the information sought.

As per the records enclosed it is noticed that the 1st Appellate Authority had failed to hear the case and pass appropriate orders on the 1st appeal filed before him.

As the appellant did not get information from the Public Information Officer, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him.

The 2nd Appeal was taken on file and notices were issued to the parties concerned for hearing on **20-04-2022**.

On 20-04-2022 the case is called. The Appellant is absent. The Public Information Officer / Deputy Commissioner, Circle-17, Khairathabad, GHMC, Hyderabad is absent. The Assistant City Planner is present on behalf of the Public Information Officer. The 1st Appellate Authority is absent.

The representative of the Public Information Officer submitted that the sought information is available in the Head Office. He further assured to obtain the same and furnish to the appellant within (15) days.

The record goes to show that the 6(1) application was filed on 09-06-2020 and the Public Information Officer has not furnished sought information to the appellant even after 1 ½ years.

The appellant did not choose to attend the hearing nor filed affidavit offering his version.

The Commission directs the Public Information Officer to obtain the sought information from the Head Office and furnish the same to the appellant **within (15) days** from the date of receipt of this order and submit compliance to the Commission.

With the above direction, **the Appeal is closed.**

The Public Information Officer is **warned** to be prompt while dealing with application filed under RTI Act, 2005 and strictly adhere to the stipulated time limits with reference to Sec.7(1) of the RTI Act, 2005.
