ORDER

Sri T. LAXMI BAI, R/o Warangal District has filed a Complaint dated **20-01-2020** which was received by this Commission on **22-01-2020** for not getting the information sought by him from the PIO / O/o The Commissioner, Greater Warangal Municipal Corporation, Beside MGM Hospital, Warangal District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated **30-09-2019** under Sec.6(1) of the RTI Act, 2005, before the PIO seeking following information:

1. Kindly furnish all the relevant documents and information in respect of the approved layout vide L.P.No.273/1982 in favour of Ekashila Housing Corporation, Hanamkonda, Warangal.
2. Kindly furnish the information as to whether there is any open plot (numbered or un-numbered) plot is/are transferred in favour of then Warangal Municipality (now GWMC) while granting the above referred layout plan vide L.P.No. 273/1982 situated at Road No.3, Srinagar Colony, Opp:H.No. 5-11-581, Ward No.44, Hanamkonda, Warangal. If your answer is 'Yes' kindly furnish all the relevant documents, as to how the transfer is being effected by the landlord namely Sri T.Kamal Singh.
3. Kindly furnish the information in respect of the Plot alleged to be earmarked for 'Park' in the above layout L.P.No.273/1982 situated at Road No.3, Srinagar Colony, Opp: H.No. 5-11-581, Ward No.44, Hanamkonda, Warangal, such as how the GWMC got ownership over the said plot, the mode of transfer, the person who transferred, any consideration for the said plot and under what proceedings of GWMC Office etc., with relevant documents.
4. Kindly furnish the information as to whether any consent or signature of the landlord/owner of any plot or plots is required for the purpose of transfer of rights in favour of GWMC, Warangal is required or not.

The PIO through Lr.No. 5249/2019/RTI dated 21-12-2019 furnished reply to the complainant to pay Rs.625/- towards Xerox charges.

Stating that the information furnished by the Public Information Officer is incomplete, the complainant preferred this Complaint before this Commission requesting to arrange to furnish the information sought by him.

The Complaint was taken on file and notices were issued to the parties concerned for hearing on **18-04-2022**.

On 18-04-2022 the case is called.

The Complainant is absent. The Public Information Officer, O/o the Municipal Commissioner, GWMC, Warangal is present.

The representative of the Public Information Officer submitted that the sought information was furnished to the Complainant on 22-10-2019 by hand but the Public Information Officer failed to produce the dispatch proof.

The Complainant in her Complaint submitted that the Public Information Officer has not furnished the papers relating to the layout. She further submitted that she is aged and the Public Information Officer has not furnished the sought information inspite of earlier orders of the Commission.

The Commission directs the Public Information Officer to furnish sought information to the Complainant **within (15) days from** the date of receipt of this order and submit compliance to the Commission.

With the above direction, **the Complaint is closed.**
