ORDER

Smt J. Sreelatha, R/o Peddapalli District filed 2nd appeal dated 23-09-2020 which was received by this Commission on 25-09-2020 for not getting the information sought by her from the PIO / O/o The Kakathiya Urban Development(KUDA), Hanamakonda, Warangal District and 1st Appellate Authority / O/o The Kakathiya Urban Development(KUDA), Hanamakonda, Warangal District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **19-06-2020** under Sec.6(1) of the RTI Act, 2005, before the PIO seeking the following information:

నేను ఖరీదైన క్రొలవేట బ్లాక్ ఖరీదైన లాండ్ డెవలప్ మెంట్ కంపెనీ నుండి నా స్వంత ప్లాట్ (హాస్టల్ క్వార్టర్స్) ఖరీదైన నంబరు గల రిసిడెన్షియల్ ప్లాట్ డెవలప్ మెంట్ LRS (Application Number KUDAL028442) తేదీ 15-02-2018 లో కేంద్రీకృతముగా ఆమోదించబడినది. అప్పుడు LRS నంబరు నమోదు చేసేటప్పుడు నా phone number లోకేట్ చేసినట్లుగా ఫోన్ రికార్డింగ్ కోపీస్ లోకేట్ చేయమని కోరాను. కానీ ఫోన్ రికార్డింగ్ కోపీస్ సమర్పించలేదు. 2005 క్రింద నా Resi-దెన్షియల్ ప్లాట్ LRS ఫోన్ రికార్డింగ్ కోపీస్ నా క్రింద పంపించమని కోరాను. కానీ నా నివాస చిరునామాకు పంపించలేదు. ఫోన్ రికార్డింగ్ కోపీస్ పంపించమని కోరాను.

ప్రార్థనలు చూచునట్లు,
వివేక LRS డివైజ్ & Acknowledgement - zero copy ని ఇవ్వమని కోరాను.

The Public Information Officer has not furnished the sought information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1st appeal dated **03-08-2020** before the 1st Appellate Authority requesting him to furnish the information sought.

As per the records enclosed it is noticed that the 1st Appellate Authority had failed to hear the case and pass appropriate orders on the 1st appeal filed before him.

As the appellant did not get information from the Public Information Officer, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him.

The 2nd Appeal was taken on file and notices were issued to the parties concerned for hearing **on 18-04-2022**.

On 18-04-2022 the case is called. The Appellant is absent. The Public Information Officer, O/o the Kakatiya Urban Development Authority, KUDA, Hanumakonda is absent. The 1st Appellate Authority is absent.

The record goes to show that the 6(1) application was filed on 19-06-2020 and the Public Information Officer has not furnished sought information to the appellant even after nearly two years.

The Commission directs the Public Information Officer to furnish sought information to the appellant **within (15) days** from the date of receipt of this order and submit compliance to the Commission.

With the above direction, the Appeal **is closed**.

Issue **show cause notice** to Public Information Officer for not furnishing the sought information to the appellant within the stipulated time and for not attending hearing in the Commission. The action on the show cause notice shall be dealt with separately.
