ORDER

DR.P.LAKSHMINARAYANA, R/o Warangal Urban District filed 2nd appeal dated 29-09-2020 which was received by this Commission on 01-10-2020 for not getting the information sought by him from the PIO / O/o The Commissioner, Greater Warangal Municipal Corporation, Warangal District and 1st Appellate Authority / O/o The Commissioner, Greater Warangal Municipal Corporation, Warangal District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 15-06-2020 under Sec.6(1) of the RTI Act, 2005, before the PIO seeking the following information:

Information under section 6(1) of RTI Act 2005.

1. Certified Copy of occupancy certificate vide File No. SBA. No. HO/G1/8289/2015, 416/2014-15 dt. 21-4-2017
2. As per the occupancy certificate, the floorwise plinth area, common area i.e., Built up area to be registered.
3. As per above occupancy certificate the plinth area and common area i.e., built up area to be registered in respect of Flat No. 102 HNo. 2-5-267 to 270, ~~Makkalagutta, Hanamkonda~~ ~~Makkalagutta~~ and also linear measurements of the Flat No. 102.

I, herewith undertake to bear expenses proposed to be met, while issuing the above information, the same may kindly be estimated to my mobile no. 9848113330 to enable me to pay to save delay.

The Public Information Officer through letter No. E-108341/2020 dated 08-07-2020 furnished the sought information to the appellant.

Stating that the information furnished by the Public Information Officer is incomplete / incorrect, the appellant filed 1st appeal dated 29-07-2020 before the 1st Appellate Authority requesting him to furnish the information sought.

As per the records enclosed it is noticed that the 1st Appellate Authority had failed to hear the case and pass appropriate orders on the 1st appeal filed before him.

As the appellant did not get information from the Public Information Officer, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him.

The 2nd Appeal was taken on file and notices were issued to the parties concerned for hearing **on 18-04-2022**.

On 18-04-2022 the case is called. The Appellant is absent. The Public Information Officer, O/o the Municipal Commissioner, GWMC, Warangal is present. The 1st Appellate Authority is absent.

The representative of the Public Information Officer submitted that the sought information was furnished to the appellant on 14-12-2020 by RPAD. The Public Information Officer produced copy of information furnished along with dispatch proof.

The appellant did not choose to attend the hearing nor filed affidavit offering his version.

Since information is furnished, **the Appeal is closed.**
