ORDER

Sri RAMZAN ALI, R/o Warangal District filed 2nd appeal dated 05-10-2020 which was received by this Commission on 08-10-2020 for not getting the information sought by him from the PIO / O/o The Inspector Auditor Waqf, Collectorate, Warangal Urban District and 1st Appellate Authority / O/o The District Revenue Officer, Warangal Urban District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 18-06-2020 under Sec.6(1) of the RTI Act, 2005, before the PIO seeking the following information:

1. Furnish me the certified copies of the Abudul Nabi Shah Complex of all shutters old & new lease & rent agreements of all tenants with paid invoices record with till date with waqf board approved leased copies.
2. Furnish me the certified copies of the scrap shops leased & rent agreements with paid invoices record with till date with waqf board approved leased copies.
3. Furnish me the Hotel Green Bavarchi old & new Leased agreement with paid invoices record with till date with waqf board approved copies.
4. Furnish me the paid salaries copies of imam mouzans with signature of present & past worked imam & mouzans.
5. Furnish me the Current bills paid invoices & pending invoices of Masjid & Darga.
6. Furnish me the income & expenditure copies with yearly waqf board fund submitted copies.
7. Furnish me the waqf board approved plan & approved leased agreement to construe madersa with allotted area with mention yards.
8. Furnish me the statement of accounts of receipts and expenditure of madersa Taj E Deccan submitted to the wakf board, of One Crore and above claimed by muthawalli.
9. Furnish me the copies of development construction expenses of masjid & darga of till date, which was completed in muthawalli supervision were mutawali claimed that masjid has been constructed with the income of Abdul Nabi Shah complex nor with the funds of pilgrims.
10. Furnish me the yearly income & expenditure copies of till date.
11. Furnish me the kaliyani biryani hotel old & new Leased & rent agreement with paid invoices record with till date with waqf board approved copies.
12. Furnish me the Kashmir fruit house hotel old & new Leased & rent agreement with paid invoices record with till date with waqf board approved copies.
13. Furnish me the Veejeta electronics old & new Leased & rent agreement with paid invoices record with till date with waqf board approved copies.

The Public Information Officer has not furnished the sought information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1st appeal dated 04-08-2020 before the 1st Appellate Authority requesting him to furnish the information sought.

The First Appellate Authority through notice No. C4/1504/2020 dated 09-09-2020 posted the first appeal for hearing on 23-09-2020.

As the appellant did not get information from the Public Information Officer, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him.

The 2nd Appeal was taken on file and notices were issued to the parties concerned for hearing on **15-06-2022**.

On **15-06-2022** the case is called. The Appellant is absent. The Public Information Officer / Wakf Inspector, O/o the District Collector, Warangal Urban District is present. The 1st Appellate Authority is absent.

The Public Information Officer submitted that the available information was furnished to the appellant on 25-9-2020 and the deemed Public Information Officer / Muthavalli was directed to furnish the information directly to the appellant vide their office letter No.1061/Rent/Wakf/Wgl/2005 dated 23-6-2020 but the Muthavalli has not furnished the information.

The Commission took a serious view in the delay of furnishing information and adjourned the case with a direction to the deemed Public Information Officer / Muthavalli to furnish the remaining information to the appellant within (15) days from the date of receipt of this order and report compliance to the Commission.

With the above direction, **the Appeal is adjourned** for compliance by the Public Information Officer.
