## **ORDER**

Sri TAJ AHMED KHAN, R/o Hyderabad District has filed a Complaint dated 03-10-2020 which was received by this Commission on 08-10-2020 for not getting the information sought by him from the PIO / O/o The Assistant City Planner, Circle-12, Mehandipatnam, Khairtabad Zone, Hyderabad.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated 28-02-2020 under Sec.6(1) of the RTI Act, 2005, before the PIO seeking following information:

the following documents.

1. Copy of the Reply to the Notice on 16.12.2019 submitted by Smt. Rasheeda Ahmed.
  2. Copy of the sanctioned building plan issued by the erstwhile Municipal Corporation of Hyderabad on 28.08.1978 in respect of H.No. 10-3-299/A/B, Humayun Nagar, Hyderabad to Smt. Rasheeda Ahmed.
  3. If no building plan is approved for the aforementioned premises, whether the erstwhile Municipal Corporation of Hyderabad or the GHMC had/has initiated steps for demolition of unauthorised construction.
- Whether the owner of the aforementioned premises has applied for BPS/BRS; if so, copies of the said application along with supporting documents.
- Whether the owner of the aforementioned premises obtained any BPS/BRS; if so, copies of the BPS/BRS along with the plan and permit for the same.

The PIO has not furnished the sought information to the complainant.

As the complainant did not receive the sought information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him.

The Complaint was taken on file and notices were issued to the parties concerned for hearing on 20-04-2022.

On 20-04-2022 the case is called. The Complainant is absent. The Public Information Officer / Deputy Commissioner, Circle-12, Mehandipatnam, GHMC, Hyderabad is present.

The Public Information Officer submitted that the sought information was furnished to the Complainant on 22-03-2022 vide letter No.563/ACP/C12/KZ/GHMC/2022 by speed post.

The Complainant did not choose to attend the hearing nor filed affidavit offering his version.

Since factual information is furnished, **the Complaint is closed.**
