ORDER

Smt S. PURNIMA, R/o Warangal Rural District filed 2nd appeal dated 20-01-2020 which was received by this Commission on 23-01-2020 for not getting the information sought by her from the PIO / O/o The District Registrar, Warangal District and 1st Appellate Authority / O/o The Commissioner & Inspector General of Registration & Stamps, Telangana, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **29-04-2019** under Sec.6(1) of the RTI Act, 2005, before the PIO seeking certain information.

The Public Information Officer through Letter No. RTI/Peshi.No./1285/2019 dated 11-11-2019 transferred the application U/s 6(3) to the Public Information Officer, O/o The District Registrar, Warangal District for furnishing the sought information.

The Public Information Officer through letter No. RTI/5043/18 dated 22-10-2018 informed to the appellant that her complaint date 07-08-2018 was transferred to the District Registrar on 18-04-2018 to enquiry and report. He further informed appellant on 11-11-2019 that the 6(1) application is transferred u/s 6(3) to District Registrar, Warangal.

Since the appellant did not receive the information from the Public Information Officer, he filed 1st appeal dated **11-09-2018** before the 1st Appellate Authority requesting him to furnish the information sought.

As per the records enclosed it is noticed that the 1st Appellate Authority had failed to hear the case and pass appropriate orders on the 1st appeal filed before him.

As the appellant did not get information from the Public Information Officer, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him.

The 2nd Appeal was taken on file and notices were issued to the parties concerned for hearing on **10-05-2022**.

On **10-05-2022** the case is called. The Appellant is absent. The Public Information Officer / District Registrar, Registration and Stamps Department, Warangal is absent. The 1st Appellate Authority is present.

The 1st Appellate Authority submitted that part information was furnished on 22-10-2018.

The appellant did not choose to attend the hearing nor filed affidavit offering his version.

Heard the 1st Appellate Authority and perused the records.

The appellant in her 6(1) application sought the enquiry report of the District Registrar, Warangal Urban on her application dated 7-8-2018. As per Public Information Officer the application of the appellant was forwarded to the District Registrar, Warangal for enquiry and report and the same is still awaited.

The Commission directs the Public Information Officer to furnish the latest status of matter to the appellant duly obtaining from the District Registrar, Warangal Urban **within (15) days** from the date of receipt of this order and submit compliance to the Commission.

With the above direction, **the Appeal is closed.**
