ORDER

Sri V. NARSIMHA BABU, R/o Warangal Urban District filed 2nd appeal dated 08-10-2020 which was received by this Commission on 13-10-2020 for not getting the information sought by him from the PIO / O/o The Greater Warangal Municipal Corporation, Warangal District and 1st Appellate Authority / O/o The Greater Warangal Municipal Corporation, Warangal District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 08-10-2020 under Sec.6(1) of the RTI Act, 2005, before the PIO seeking the following information:



1. Certified Copy of Occupancy Certificate vide file No & B.No. HO/G1/8289/2015, 416/2014-15 dt. 21-04-2017.
2. As per above occupancy certificate the floorwise plinth area, & Common area i.e Builtup area to be registered.
3. As per above occupancy certificate the plinth area and common area i.e builtup area to be registered in respect of Flat No 204, H No 2-5267 to 270, Nalkalagutta, Hazratnagar and also the various measurements of the Flat No 204.

The Public Information Officer has not furnished the sought information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1st appeal dated 15-06-2020 before the 1st Appellate Authority requesting him to furnish the information sought.

As per the records enclosed it is noticed that the 1st Appellate Authority had failed to hear the case and pass appropriate orders on the 1st appeal filed before him.

As the appellant did not get information from the Public Information Officer, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him.

The 2nd Appeal was taken on file and notices were issued to the parties concerned for hearing on 30-06-2022.

On 30-06-2022 the case is called. The Appellant is absent. The Public Information Officer / Assistant City Planner, GWMC, Warangal is present. The 1st Appellate Authority is absent.

The Public Information Officer submitted that the 1st Appellate Authority has furnished sought information to the appellant on 31-12-2020, but he did not produce the dispatch proof.

The appellant did not choose to attend the hearing nor filed affidavit offering his version.

The Commission directs the Public Information Officer to furnish sought information once again to the appellant by RPAD within (15) days from the date of receipt of this order and submit compliance to the Commission.

With the above direction, **the Appeal is closed.**
