## ORDER

**Sri V. Srinivasa Chary, R/o Karimnagar District** filed 2<sup>nd</sup> appeal dated 16-10-2020 which was received by this Commission on 16-10-2020 for not getting the information sought by him from the PIO / O/o The Commissioner, Karimnagar Municipal Corporation, Karimnagar District and 1<sup>st</sup> Appellate Authority / O/o The Commissioner, Karimnagar Municipal Corporation, Karimnagar District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **13-07-2020** under Sec.6(1) of the RTI Act, 2005, before the PIO seeking the following information:

The Public Information Officer through letter No. G2/318/R.T.I/2020 dated 19-09-2020 furnished the sought information to the appellant.

Stating that the information furnished by the Public Information Officer is incomplete / incorrect, the appellant filed 1<sup>st</sup> appeal dated **15-09-2020** before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought.

As per the records enclosed it is noticed that the 1<sup>st</sup> Appellate Authority had failed to hear the case and pass appropriate orders on the 1<sup>st</sup> appeal filed before him.

As the appellant did not get information from the Public Information Officer, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to arrange to furnish the information sought by him.

The 2nd Appeal was taken on file and notices were issued to the parties concerned for hearing on **09-05-2022**.

On **09-05-2022** the case is called. The Appellant is absent. The Public Information Officer, O/o the Municipal Commissioner, Karimnagar Municipal Corporation, Karimnagar is present. The 1st Appellate Authority is absent.

The Public Information Officer submitted that the sought information was furnished to the appellant on 19-9-2020 vide letter No.G2/318/RTI/2020.

Heard the Public Information Officer and perused the records.

The appellant in his 6(1) application sought action taken report on his Complaint dated 7-5-2020 for removal of illegal constructions by Smt.V.Archana and V.Aruna as per Court orders, whereas the Public Information Officer informed that no permission is granted to the above persons for constructions of houses. Thus, the Public Information Officer has furnished irrelevant information.

The appellant did not choose to attend the hearing nor filed affidavit offering his version.

The Commission directs the Public Information Officer to furnish action taken report on his Complaint dated 7-5-2020 for removal of illegal constructions by Smt.V.Archana and Smt.V.Aruna to the appellant **within (15) days** from the date of receipt of this order and submit compliance to the Commission.

With the above direction, **the Appeal is closed.**
