## **ORDER**

**Sri V. Srinivasa Chary, R/o Karimnagar District** filed 2<sup>nd</sup> appeal dated 16-10-2020 which was received by this Commission on 16-10-2020 for not getting the information sought by him from the PIO / O/o The Commissioner, Karimnagar Municipal Corporation, Karimnagar District and 1<sup>st</sup> Appellate Authority / O/o The Commissioner, Karimnagar Municipal Corporation, Karimnagar District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **02-07-2020** under Sec.6(1) of the RTI Act, 2005, before the PIO seeking the following information:

The Public Information Officer through letter No. G2/219/R.T.I/2020 dated 10-08-2020 informed the appellant to inspect the file at their office on 14-08-2020.

Since the appellant did not receive the information from the Public Information Officer, he filed 1<sup>st</sup> appeal dated **15-09-2020** before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought.

As per the records enclosed it is noticed that the 1<sup>st</sup> Appellate Authority had failed to hear the case and pass appropriate orders on the 1<sup>st</sup> appeal filed before him.

As the appellant did not get information from the Public Information Officer, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to arrange to furnish the information sought by him.

The 2nd Appeal was taken on file and notices were issued to the parties concerned for hearing on **09-05-2022**.

On **09-05-2022** the case is called. The Appellant is absent. The Public Information Officer, O/o the Municipal Commissioner, Karimnagar Municipal Corporation, Karimnagar is present. The 1st Appellate Authority is absent.

The Public Information Officer submitted that the sought information was furnished to the appellant on 10-8-2020. He further submitted that the matter was referred to the District Task Force for taking further action.

The appellant did not choose to attend the hearing nor filed affidavit offering his version.

The Commission directs the Public Information Officer to furnish the latest status of matter to the appellant **within (15) days** from the date of receipt of this order and submit compliance to the Commission.

With the above direction, **the Appeal is closed.**
