ORDER

Sri MOHD ASHRAF, R/o Komaram Bheem District has filed a Complaint dated 12-10-2020 which was received by this Commission on 21-10-2020 for not getting the information sought by him from the PIO / O/o The Secretary, TMREIS, Banjara Hills, Road No.10, Hyderabad.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated 24-08-2020 under Sec.6(1) of the RTI Act, 2005, before the PIO seeking following information:

- 1.మీ పరిధి లోని పాఠశాలలలో ఎంత మెటీరియల్ LOCK Down వలన చెడిపోయింది వాటి జాబితా, విలువ మరియు పంచనామా ప్రతిలు ఇవ్వగలరు.
- 2.LOCK Down వలన materials చెడిపోకుండా ప్రభుత్వం ఇచ్చిన ఆదేశాలు మీ పరిధి లోని పాఠశాలలలో మిగిలిన materialsలను ప్రభుత్వం ఇచ్చిన ఆదేశాలు ప్రకారం మీరు చేపట్టిన చర్యలు వాటి రుజువు వాటి జాబితా, విలువ మరియు పంచనామా ప్రతిలు ఇవ్వగలరు
3. మీ పరిధి లోని పాఠశాలలకు సంబంధించిన ఆడిట్ Para's ను 2016-17 నుండి నేటివరకు ఇవ్వగలరు.
4. మీ పరిధిలోని పాఠశాలలలో క్రీస్టియన్ మైనారిటీ విభాగంలో అడ్మిషన్ పొందిన వారి అప్లికేషన్ ప్రతులు వీరి పేర్లను నమోదు చేసిన అడ్మిషన్ రిజిస్టర్ ప్రతి మరియు టైల్డ్ ఇన్స్ లో ఏ Caste ను నమోదు చేసినారు దాని ప్రతులు ను 2016-17 నుండి నేటివరకు ఇవ్వగలరు.
5. మీ పరిధిలోని పాఠశాలలకు నేరుగా కొనుగోలు చేయడానికి ఇచ్చిన అనుమతి ప్రతులు మరియు మీ ఆదేశాల ప్రకారం వారు ఖర్చు చేసే మీకు సమర్పించిన బిల్లులు, వౌచర్స్, Cash Books మరియు పర్మిసింగ్ కమిటీ అనుమతి ప్రతులు; టెండింగ్ బిల్డ్స్ వివరాలు ను 2016-17 నుండి నేటివరకు ఇవ్వగలరు

The PIO has not furnished the sought information to the complainant.

As the complainant did not receive the sought information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him.

The Complaint was taken on file and notices were issued to the parties concerned for hearing on 19-04-2022.

On 19-04-2022 the case is called. The Complainant is absent. The Public Information Officer, O/o the Secretary, TMREIS, Banjara Hills, Hyderabad is absent.

The representative of the Public Information Officer came to the office after hearing and submitted that the notice was received in the morning and the Public Information Officer is on leave and hence requested for adjournment of the case.

In view of the above, the Complaint was adjourned to 18-05-2022.

On 18-05-2022 the case is called. The Complainant is absent. The Public Information Officer / Assistant Secretary, TMREIS, Banjara Hills, Hyderabad is present.

The Public Information Officer submitted that the applicant sought information of many subjects by way one application and as such he was informed on 2-12-2020 vide letter No.A5/6749/TMREIS/2020 to seek information on specific matters. He further submitted that the applicant sought vast information on various items of TMREIS Schools of entire State which needs collection of material from all the Schools which takes lot of time.

The Commission is of the view that the applicant has sought voluminous information on various items of Schools located in the entire State.

In this context it would be relevant to refer to the decision of the Hon'ble Apex Court in the Civil Appeal No. 6454 of 2011 (arising out of SLP(C) No. 7526/2009 in CBSE and Anr (Appellants) Vs. Aditya Bandopadhyay & others (Respondents). Wherein the Court observed thus:

"The right to information is a cherished right. The provisions of RTI Act should be enforced strictly and all efforts should be made to bring to light the necessary information under clause (b) of section 4(1) of the Act which relates to securing transparency and accountability in the working of public authorities and in discouraging corruption. Indiscriminate and impractical demands or directions under RTI Act for disclosure of all and sundry information (unrelated to transparency and accountability in the functioning of public authorities and eradication of corruption) would be counter-productive as it will adversely affect the efficiency of the administration and result in the executive getting bogged down with the non-productive work of collecting and furnishing information. The nation does not want a scenario where 75% of the staff of public authorities spends 75% of their time in collecting and furnishing information to applicants instead of discharging their regular duties. The threat of penalties under the RTI Act and the pressure of the authorities under the RTI Act should not lead to employees of a public authorities prioritizing 'information furnishing', at the cost of their normal and regular duties."

Following the ratio laid-down in the above decision the applicant is advised to restrict his questions to minimum possible and to ask specific questions.

The Complainant did not choose to attend the hearing nor filed affidavit offering his version.

In view of the above, the Commission directs the Public Information Officer to furnish the available information of their office to the Complainant **within (15) days** from the date of receipt of this order and report compliance to the Commission.

With the above direction, the **Complaint is closed.**
