## **ORDER**

Sri MOHD ASHRAF, R/o Komaram Bheem District has filed a Complaint dated 12-10-2020 which was received by this Commission on 21-10-2020 for not getting the information sought by him from the PIO / O/o The District Minority Welfare Officer, Nirmal District

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated 03-09-2020 under Sec.6(1) of the RTI Act, 2005, before the PIO seeking following information:

1. మీ పరిధిలో ఉన్న పాఠశాలలలో పనిచేస్తున్న సెల్ఫ్-హెల్ప్డ్ outsource service లో ఉన్న teaching staff వారి  
job notification, Appointment Order, Joining Report లను తి గత 6 నెలల వరకు బిల్ మరియు ఇవ్వగలరు.

The PIO through Lr.No.A/2/RTI/2020 dated 11-09-2020/19 furnished the sought information to the complainant.

Stating that the information furnished by the Public Information Officer is incomplete / incorrect, the complainant preferred this Complaint before this Commission requesting to arrange to furnish the information sought by him.

The Complaint was taken on file and notices were issued to the parties concerned for hearing on 30-06-2022.

On 30-06-2022 the case is called. The Complainant is absent. The Public Information Officer / District Minority Welfare Officer, Nirmal is present.

The Public Information Officer submitted that the 6(1) application was transferred to the Public Information Officers / Principals of TMREI Schools i.e. Nirmal(G), Nirmal(B), Mudhole(G), Khanapur(B), Bhainsa(B) on 11-9-2020 U/s. 6(3) of RTI Act, 2005 requesting them to furnish sought information to the Complainant.

The Public Information Officer further submitted that they have furnished information to the Complainant on 15-9-2020, 24-9-2020, 21-9-2020, 19-9-2020 and 21-9-2020.

The Complainant did not choose to attend the hearing nor filed affidavit offering his version.

The Commission observed that the Public Information Officer ought to have asked the Complainant to file separate 6(1) application before each Public Information Officer instead of transferring U/s. 6(3) of RTI Act, 2005.

As the information is furnished, the Complaint is closed.
