ORDER

Sri MOHD AMANUDDIN, R/o Secunderabad District filed 2nd appeal dated 20-10-2020 which was received by this Commission on 22-10-2020 for not getting the information sought by him from the PIO / O/o The Chief Executive Officer, Telangana State Waqf Board Office Razzak Manzil opp Public Garden, Nampally, Hyderabad and 1st Appellate Authority / O/o The Chief Executive Officer, Telangana State Waqf Board Office Razzak Manzil opp Public Garden, Nampally, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 09-06-2020 under Sec.6(1) of the RTI Act, 2005, before the PIO seeking the following information:

following clarifications and its reply:

1. The copy of the complete file submitted by the commissioner surveyed the site of Mukramjahi masque Madhira and published in gazette 1990 as supplementary to part – II of 1990 may please be made available.
2. Kindly intimate the area allotted by the then government for construction of Mukramjahi Mosque near Railway Station Madhira is 80' X 80' and as per sanctioned plan available in wakfboardoffice records, submitted by the applicant Abdul Rahman in Urdu and approved by the then government. Copy may please be made available.
3. The area of measurements shown in A.P.Gazette 1990 supplementary to Part - II is 199' X 640'. This is excess than the area of measurements shown in original sanctioned plan by the then government ie. 80' X 80' with its boundaries'. Kindly intimate the source of the excess area shown in gazette. Kindly made available the copies of the source of excess area.
4. The copy of the gazette published in 1990 as part – I and Part – II and prior to it pertaining to wakf properties in the then A.P.State may please be made available.

The Public Information Officer through letter No. S-12/RTIA/2020 dated 05-08-2020 furnished reply to the appellant.

Stating that the information furnished by the Public Information Officer is incomplete / incorrect, the appellant filed 1st appeal dated 20-07-2020 before the 1st Appellate Authority requesting him to furnish the information sought.

As per the records enclosed it is noticed that the 1st Appellate Authority had failed to hear the case and pass appropriate orders on the 1st appeal filed before him.

As the appellant did not get information from the Public Information Officer, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him.

The 2nd Appeal was taken on file and notices were issued to the parties concerned for hearing on **19-04-2022**.

On 19-04-2022 the case is called. The Appellant is absent. The Public Information Officer, O/o the CEO, T.S.Wakq Board, Nampally, Hyderabad is absent. The 1st Appellate Authority is absent.

The Public Information Officer filed a letter dated 18-4-2022 submitting that the staff of the entire Wakq Board are busy in duties for distribution of Gift packets to the Muslim community as ordered by the Government on the eve of Ramzan. Hence the Public Information Officer requested to adjourn the case after Ramzan.

In view of the above, the **Appeal was adjourned to 18-05-2022**.

On 18-05-2022 the case is called. The Appellant is absent. The Public Information Officer, O/o the Telangana State Wakq Board, Haj House, Nampally, Hyderabad is present. The 1st Appellate Authority is absent.

The Public Information Officer submitted that the appellant was informed on 5-8-2020 to provide specific file number in respect of point no.1 and with regard point nos.2, 3, 4 the information was furnished to the appellant on 16-05-2022.

The record goes to show that the 6(1) application was filed on 11-6-2020 and the information has been furnished to the appellant with delay of two years.

The appellant did not choose to attend the hearing nor filed affidavit offering his version.

Since information is furnished, **the Appeal is closed.**

The Public Information Officer is **warned** to be prompt while dealing with application filed under RTI Act, 2005 and strictly adhere to the stipulated time limits with reference to Sec.7(1) of the RTI Act, 2005.
