ORDER

1. **Sri N. KARUNAKAR, R/o Nalgonda District** has filed a Complaint dated 22-10-2020 which was received by this Commission on 29-10-2020 for not getting the information sought by him from the PIO / O/o The Superintending Engineer, OMC, TS TRANSCO, Nalgonda District.

2. The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated **11-09-2020** before the PIO requesting to furnish the information under Sec.6(1) of the RTI Act, 2005, on the following points mentioned in his application.

3. The Public Information Officer has not furnished information to the Complainant.

4. As the Complainant did not receive the required information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

The Complaint was taken on file and notices were issued to the parties concerned for hearing on **14-06-2022**.

On 14-06-2022 the case is called. The Appellant is absent. The Public Information Officer / Superintending Engineer, TSTRANSCO, Nalgonda is present. The 1st Appellate Authority is absent.

The Public Information Officer submitted that the sought information was rejected u/s 8(1)(j) of RTI Act 2005 vide letter No.2837/2020 dated 15-12-2020.

The record goes to show that the appellant in his 6(1) application sought voluminous information including the 4(1)(b) information. He is advised to seek specific information in brief, so as enable the Commission to pass appropriate direction to the Public Information Officer.

The Commission directs the Public Information Officer to furnish the 4(1)(b) information to the appellant within (15) days from the date of receipt of this order and submit compliance to the Commission.

With above direction, **the Appeal is closed.**
