ORDER

Sri RANA KAMALASAN, R/o Hyderabad District filed 2nd appeal dated 28-10-2020 which was received by this Commission on 02-11-2020 for not getting the information sought by him from the PIO / O/o The Deputy Commissioner, Property Tax Section, Circle-14, GHMC, Goshamahal-65, Abids, Hyderabad and 1st Appellate Authority / O/o The Commissioner, GHMC, CC Complex Tank Bund Road, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 30-07-2020 under Sec.6(1) of the RTI Act, 2005, before the PIO seeking the following information:

With reference to the sheet cited above a 64/
Complaint of illegal Unauthorised construction being carried out in

Dec 2019, and so far action taken against said illegal

Construction is not known. As such I intend to ~~know~~ ^{know} the
action taken. Report against said illegal construction being or,
Complaint, the copy same may be furnished. Under

RTI Act as to whether demolition notice issued or not due before.

The Request Fee of Rs 10/ C Fee is 2/10000 Under the Act

It is therefore requested to furnish the information

as sought for at the earliest.

The Public Information Officer has not furnished the sought information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1st appeal dated 05-04-2020 before the 1st Appellate Authority requesting him to furnish the information sought.

As per the records enclosed it is noticed that the 1st Appellate Authority had failed to hear the case and pass appropriate orders on the 1st appeal filed before him.

As the appellant did not get information from the Public Information Officer, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him.

The 2nd Appeal was taken on file and notices were issued to the parties concerned for hearing **on 20-04-2022**.

On 20-04-2022 the case is called. The Appellant is absent. The Public Information Officer / Deputy Commissioner, Circle-14, Goshamahal, GHMC, Hyderabad is absent. The Deputy City Planner is present on behalf of the Public Information Officer. The 1st Appellate Authority is absent.

The representative of the Public Information Officer submitted that information is ready and is being furnished to the appellant.

The appellant did not choose to attend the hearing nor filed affidavit offering his version.

The record goes to show that the 6(1) application was filed on 30-07-2020 and no information is furnished by the Public Information Officer even after 1 ½ year.

The Commission directs the Public Information Officer to furnish **factual status** of the matter to the appellant **within (15) days** from the date of receipt of this order and submit compliance to the Commission.

With the above direction, **the Appeal is closed.**

Issue **show cause notice** to then Public Information Officer and present Public Information Officer for not furnishing the sought information to the appellant within the stipulated time. The action on the show cause notice shall be dealt with separately.
