ORDER

1. Sri DEVARAJU PALLELA, R/o Karimnagar District has filed 2nd appeal dated 31-10-2020 which was received by this Commission on 03-11-2020 for not getting the information sought by him from the PIO / O/o The Divisional Engineer(AT&P), RTS-B/Ramagundam, Peddapally District and 1st Appellate Authority / O/o The Divisional Engineer(AT&P), RTS-B/Ramagundam, Peddapally District.

2. The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 27-08-2020 before the PIO requesting to furnish the information under Sec.6(1) of the RTI Act, 2005, on the following points mentioned in his application:

ఆ సమయంలో అవసరమైన సామగ్రి ధృవీకృత. నమూనాలు ఇవ్వగలరు.

1) రామసుండు Genco కార్పొరేషన్ సంస్థలో మైక్రో కుడిగ్రనుల ఎంతమంది ఉన్నారు. ఎవరైనా వివరాలను పంపాలనుకరించండి.

2) రామసుండు Genco కార్పొరేషన్ సంస్థలో ఎన్ని ప్రాజెక్టులు శ్రీశైల కలవర అడివిమైలు ప్రాజెక్టులు, అర్జునుల తెల్లంపా.

3) రామసుండు కార్పొరేషన్ Genco సంస్థలో ఎన్ని కార్మికులు ఉన్నారు. అవి ఏమైలును వివరాలను పంపాలనుకరించండి.

3. The Public Information Officer has not furnished information to the appellant.

4. Since the appellant did not receive the information from the Public Information Officer, he filed 1st appeal dated 29-09-2020 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

5. As the appellant did not get the information from the Public Information Officer / 1st Appellate Authority even after (30) days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

The 2nd Appeal was taken on file and notices were issued to the parties concerned for hearing on 14-06-2022.

On 14-06-2022 the case is called. The Appellant is absent. The Public Information Officer / Divisional Engineer, AT&P, RTS-B, TSGENCO, Ramagundem is present. The 1st Appellate Authority is absent.

The Public Information Officer submitted that the sought information was furnished to the appellant on 23-9-2020 by RPAD vide letter No.910/2020.

The record goes to show that the appellant while admitting to have received the said information informed the Commission that he did not receive correct and complete information for item nos.1 and 2.

The Commission directs the Public Information Officer to furnish balance available information to the appellant duly following the provisions of RTI Act 2005 **within (15) days** from the date of receipt of this order and submit compliance to the Commission.

With above direction, **the Appeal is closed.**
