ORDER

1. Sri DEVARAJU PALLELA, R/o Karimnagar District has filed 2nd appeal dated 31-10-2020 which was received by this Commission on 03-11-2020 for not getting the information sought by him from the PIO / O/o The Superintending Engineer(Operation), TSNPDCL, Karimnagar District and 1st Appellate Authority / O/o The Superintending Engineer(Operation), TSNPDCL, Karimnagar District.

2. The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 27-08-2020 before the PIO requesting to furnish the information under Sec.6(1) of the RTI Act, 2005, on the following points mentioned in his application:

3. The Public Information Officer through Lr.No./DE/Operation/Karimnagar/Tech/D.No.528 dated 17-09-2020 furnished reply to the appellant.

4. Stating that the information furnished by the Public Information Officer is incomplete / incorrect, the appellant filed 1st appeal dated 28-09-2020 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

5. As per the records enclosed it is noticed that the 1st Appellate Authority had failed to hear the case and pass appropriate orders on the 1st appeal filed before him.

6. As the appellant did not get the information from the Public Information Officer / 1st Appellate Authority even after (30) days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

The 2nd Appeal was taken on file and notices were issued to the parties concerned for hearing on 14-06-2022.

On 14-06-2022 the case is called. The Appellant is absent. The Public Information Officer / Divisional Engineer, Technical, TSNPDCL, Karimnagar is present. The 1st Appellate Authority is absent.

The Public Information Officer submitted that the sought information was furnished to the appellant on 3-11-2020 vide letter No.1576/2020 by RPAD.

The appellant did not choose to attend the hearing nor filed affidavit offering his version.

Since information is furnished, **the Appeal is closed.**
