ORDER

Sri SAIMUNI MEDURU, R/o SPSR Nellore District filed 2nd appeal dated 28-10-2020 which was received by this Commission on 03-11-2020 for not getting the information sought by him from the PIO / O/o The Deputy Commissioner of Labour, Ranga Reddy Zone, T.Anjaiah Karmika Bhavan, Hyderabad and 1st Appellate Authority / O/o The Deputy Commissioner of Labour, Ranga Reddy Zone, T.Anjaiah Karmika Bhavan, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **8-07-2020** under Sec.6(1) of the RTI Act, 2005, before the PIO seeking the following information:

1. The Deputy Commissioner of Labour, Ranga Reddy has any information given to the Management to produce original resignation letter to seen.
 - 1.A. If any information given to management please give that document to me.
 - 1.B. if not given, what is reason. That information also required
2. The Deputy Commissioner of Labour, Ranga Reddy has seen the original resignation letter.
 - 2.A. if seen means, that information required.
 - 2.B. If not seen means, that information also required.
3. The Deputy Commissioner of Labour, Rangareddy will declare as The management submitted resignation is true.
 - 3.A. If said yes means i want that information.
 - 3.B. If said no means i want that information.
4. If the management submitted fake and duplicated resignation letter to you, what kind of action will take against the management, that information required.
5. If the management submitted fake and duplicate resignation letter to you, what kind of benefits have employees, their information.
6. Without settlement of resignation letter issue confirmation, what is the reason to send the appropriate government (Joint commissioner of Labour), that information also required.
7. What is the reason for disputes not settle down.

The Public Information Officer has not furnished the sought information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1st appeal dated **14-08-2020** before the 1st Appellate Authority requesting him to furnish the information sought.

The First Appellate Authority through notice No. G/507/2020 dated 24-08-2020 posted the first appeal for hearing on 10-09-2020.

As the appellant did not get information from the Public Information Officer, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him.

The 2nd Appeal was taken on file and notices were issued to the parties concerned for hearing on **24-05-2022**.

On **24-05-2022** the case is called. The Appellant is absent. The Public Information Officer, O/o the Deputy Commissioner of Labour, Ranga Reddy District is absent. The Senior Assistant is present on behalf of the Public Information Officer. The 1st Appellate Authority is absent.

The representative of the Public Information Officer filed affidavit of the Public Information Officer submitting that the sought information was furnished to the appellant on 12-8-2020 vide letter No.A/450/2020 by speed post on 13-8-2020.

Since factual information is furnished, **the Appeal is closed.**
