## **ORDER**

Sri SAIMUNI MEDURU, R/o SPSR Nellore District filed 2<sup>nd</sup> appeal dated 28-10-2020 which was received by this Commission on 04-11-2020 for not getting the information sought by him from the PIO / O/o The Principal Secretary, LET&F(L) Department, BRKR Bhavan, Hyderabad and 1<sup>st</sup> Appellate Authority / O/o The Principal Secretary, LET&F(L) Department, BRKR Bhavan, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 8-07-2020 under Sec.6(1) of the RTI Act, 2005, before the PIO seeking the following information:

- 1.I submitted my complaint to **Hon'ble Principal Secretary, LET&F(L)D, Telangana state, Hyderabad**, through Centralized Public Grievance Redress And Monitoring System (CPGRAMS), department of Administrative Reforms & Public Grievance, government of India, with Reference number : **GOVTG/E/2019/00170**, on dated: **10.02.2019**. & the Centralized Public Grievance Redress And Monitoring System complaint (GOVTG/E/2019/00170) closed dated:09.08.2019.
  2. I submitted my complaint to **Hon'ble Principal Secretary, Labour Employment Training and Factories (labour) Department, Government of Telangana, Telangana state, Hyderabad**, through Centralized Public Grievance Redress And Monitoring System (CPGRAMS), department of Administrative Reforms & Public Grievance, government of India, with Reference number : **GOVTG/E/2020/00004**, on dated: **02.01.2020**. & the Centralized Public Grievance Redress And Monitoring System complaint (GOVTG/E/2020/00004) closed dated: 06.02.2020
  3. I submitted my first remainder to the **Hon'ble Principal Secretary, Labour Employment Training and Factories (labour) Department, Government of Telangana, Telangana state, Hyderabad** on dated: 09.01.2020 by Registered Post, their registered post No:**RN640180942IN**., registered post received date:17.01.2020.
  4. I submitted my second remainder to **Hon'ble Principal Secretary, Labour Employment Training and Factories (labour) Department, Government of Telangana, Telangana state, Hyderabad**, through Centralized Public Grievance Redress And Monitoring System (CPGRAMS), department of Administrative Reforms & Public Grievance, government of India, with Reference number : **GOVTG/E/2020/00122**, on dated: 07.02.2020. & the Centralized Public Grievance Redress And Monitoring System complaint (GOVTG/E/2020/00122) not closed till dated.
  - 5.I submitted a notice to **Hon'ble Principal Secretary, Labour Employment Training and Factories (labour) Department, Government of Telangana, Telangana state, Hyderabad**, dated on: 11.03.2020 through Registered post, their reference No: **RN666391881IN** Registered post received dated:16.03.2020

The Public Information Officer has not furnished the sought information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1<sup>st</sup> appeal dated 13-08-2020 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought.

As per the records enclosed it is noticed that the 1<sup>st</sup> Appellate Authority had failed to hear the case and pass appropriate orders on the 1<sup>st</sup> appeal filed before him.

As the appellant did not get information from the Public Information Officer, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to arrange to furnish the information sought by him.

The 2nd Appeal was taken on file and notices were issued to the parties concerned for hearing on 24-05-2022.

**On 24-05-2022** the case is called. The Appellant is absent. The Public Information Officer / Assistant Secretary, LET&F Department, BRKR Bhavan, Hyderabad is present. The 1st Appellate Authority is absent.

The Public Information Officer submitted that the sought information was already furnished to the appellant earlier many times and again on 29-8-2020 and 21-11-2020. The appellant was further informed that seeking reasons / opinions / questioners do not come under the provisions of RTI Act 2005 and hence rejected. He further submitted that while forwarding of the report of Commissioner of Labour on 24-8-2020, the individual was requested to approach the Labour Court as advised by the Commissioner of Labour. Despite furnishing the information several times the appellant is seeking same information often.

The appellant did not choose to attend the hearing nor filed affidavit offering his version.

The Commission observed that the same matter was earlier heard in Appeal No.357/SIC-Dr.MA/2020 dated 21-03-2022 and disposed off while admonishing the appellant to desist seeking same information repeatedly.

Since factual information is furnished, **the Appeal is closed.**
