ORDER

1. Sri A.N.DASARATH, R/o.H.No.1-24-49/50, Sidhu Sadan Apartments, Dwaraka Nagar, alwal, Secunderabad-500015, Hyderabad Dist has filed a Complaint dated 6-11-2020 which was received by this Commission on 6-11-2020 for not getting the information sought by him from the PIO / O/o The District Registrar of Cooperative Societies, Near Niloufer Hospital, Red Hills, Lakidakapul, Hyderabad-500004.

2. The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated 25-3-2019 before the PIO requesting to furnish the information under Sec.6(1) of the RTI Act, 2005, on the following points mentioned in his application.

Kindly provide the following information regarding to Shiva Ganga Temple, Welfare Society East Marredpally, Mahindra Hills, Secunderabad. Under RTI act 2005 as follows.

1. When was the society Shiva Ganga Temple Welfare Society has been registered and what is the registration number and year and list of society members and certificates may be furnished.
2. After the society registration whether the society has submitted their minutes book and resolutions including by laws and other subsequent proceedings of the same a copy may be furnished.
3. Whether in previous four years the Shiva Ganga Temple, Welfare Society East Marredpally, Mahindra Hills, Secunderabad has changed the name furnish a copy.
4. Before changing the society name whether the society has made any intimation or notice given to the old society members furnish a set of Xerox copies.
5. Whether the society has passed any resolution in the year 2015 – 16, 2016 – 17 submit copy of the resolution.
6. Whether the society has made any request / application regarding the change of name of the society submit a copy of the application.
7. Whether the Shiva Ganga Temple, Welfare Society East Marredpally, Mahindra Hills, Secunderabad has changed the society name kindly furnish a copy of change of name.
8. Whether the Shiva Ganga Temple, Welfare Society East Marredpally, Mahindra Hills, Secunderabad has made any bye-laws regarding its society kindly furnish a copy.

3. The Public Information Officer has not furnished information to the Complainant.

4. As the Complainant did not receive the required information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

The Complaint was taken on file and notices were issued to the parties concerned for hearing on 13-06-2022.

On 13-06-2022 the case is called. The Complainant is present. The Assistant Public Information Officer, O/o the District Registrar, Registration & Stamps Department, Hyderabad District is present.

The Complainant submitted that he did not receive the sought information from the Public Information Officer.

The representative of the Public Information Officer submitted that the sought information was furnished to the Complainant vide letter No.RTI/2146/2019 dated 23-4-2019.

Heard both the parties and perused the records.

The Commission directs the Public Information Officer to invite the Complainant to his office on any mutually convenient date during office hours and permit him to inspect the records and furnish required information and report compliance to the Commission. The entire process shall be completed **within (30) days** from the date of receipt of this order.

With the above direction, **the Complaint is closed.**
