ORDER

1. **Sri V. JANARDHAN, R/o Hyderabad District** has filed a Complaint dated 12-11-2020 which was received by this Commission on 12-11-2020 for not getting the information sought by him from the PIO / O/o The Assistant Engineer, TSSPDCL, Shamshabad Mandal, Ranga Reddy District.

2. The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated **31-10-2020** before the PIO requesting to furnish the information under Sec.6(1) of the RTI Act, 2005, on the following points mentioned in his application.

ఎ) కరెంటు మీటరు నెం. యజమాని పేరు, చిరునామా.
బి) వీటికి సంబంధించి కరెంటు బిల్లుల పెండింగ్ వివరాలు.
సి) కరెంటు బిల్లులు చెల్లించక పోతే మీరు తీసుకుంటున్న చర్యలు.
డి) ఇప్పటి వరకు వీటిపై పేరుకు పోయిన బిల్లుల మొత్తం వివరాలు.
ఇ) పై ప్లాట్లలో మీరు మీటర్లు తొలగించితే వాటికి సంబంధించిన వివరాలు (ప్లాట్ నెం., యజమాని పేరు, చిరునామా)

3. The Public Information Officer has not furnished information to the Complainant.

4. As the Complainant did not receive the required information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

The Complaint was taken on file and notices were issued to the parties concerned for hearing on **14-06-2022**.

On **14-06-2022** the case is called. The Complainant is present. The Public Information Officer / Assistant Engineer, TSSPDCL, Shamshabad, Ranga Reddy District is present.

The Complainant submitted that he did not receive the sought information from the Public Information Officer.

The Public Information Officer submitted that part information is brought now and the same will be furnished to the Complainant. He further sought (30) days time to furnish the balance information to the Complainant.

As per directions of the Information Commission, the part information is furnished to the Complainant in the presence of the Information Commission.

The Commission directs the Public Information Officer to furnish the balance information to the Complainant by RPAD as assured **within (30) days from** the date of receipt of this order and submit compliance to the Commission.

With the above direction, **the Complaint is closed.**
