## **ORDER**

1. Sri DIWAKER REDDY KATTA, H.No.13-255-3/A, Plot No.34, Sy.79/Part, Chandra nagar Colony, Near Royal Function Hall, Medchal District - 501 401 has filed 2<sup>nd</sup> appeal dated 9-11-2020 which was received by this Commission on 13-11-2020 for not getting the information sought by him from the PIO / O/o The Syndicate Farmers Cooperative Society Limited, Alwal, Secunderabad-500010 and 1<sup>st</sup> Appellate Authority / O/o The Deputy Registrar of Co-operative Societies, Secunderabad-500001.

2. The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 20-7-2020 before the PIO requesting to furnish the information under Sec.6(1) of the RTI Act, 2005, on the following points mentioned in his application:

The concerned PIO(s) concerned with my request are as below:

The Public Information officer, Syndicate Farmers Co-op Society Ltd. Alwal  
(Sponsored by syndicate bank), Regd no. TBC-227  
Alwal, Secunderabad - 500010.

- Please indicate the progress made on my application so far. i.e. when did my application reach which officer, for how long did it stay with that officer and what did he/she do during that period?
- Please give the names and designations of the officials who were supposed to act on my application and who have not done so?
- What is the retention period of record that is related with this RTI application. Kindly mention the rule under which the record has been destroyed, if it is? If the record is untraceable, who are the officials responsible for not maintaining it.
- Please mention the Rule/Law (whether state or central) if the requested information cannot be given to me by the Public Information Officer(s) concerned?
- Please inform me if I am supposed to pay any additional amount to the concerned PIO/accounts officer towards providing the requested information by me above, under RTI act-2005, also mention the mode of payment I must do (if any)
- I have herewith attached (Rs.10/-) as application fee with the original application: vide court fee stamps/IPO.

3. The Public Information Officer has not furnished information to the appellant.

4. Since the appellant did not receive the information from the Public Information Officer, he filed 1<sup>st</sup> appeal dated 16-9-2020 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

5. As the appellant did not get the information from the Public Information Officer / 1<sup>st</sup> Appellate Authority even after (30) days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

The 2nd Appeal was taken on file and notices were issued to the parties concerned for hearing on **13-06-2022**.

**On 13-06-2022** the case is called. The Appellant is absent. The Public Information Officer / Manager, Syndicate Farmers Cooperative Society, Alwal, Secunderabad is present. The 1st Appellate Authority is absent.

The Public Information Officer submitted that the sought information was furnished to the appellant on 07-10-2020.

The appellant did not choose to attend the hearing nor filed affidavit offering his version.

Since information is furnished, **the Appeal is closed.**
