ORDER

1. Sri THATI MURALI, Advocate, H.No.12-151, Srinivasa Nagar, Kodad Town, Suryapet District-508206 has filed a Complaint dated 16-11-2020 which was received by this Commission on 16-11-2020 for not getting the information sought by him from the PIO / O/o The Nalgonda District Co-operative Central Bank Limited, Nalgonda District-508001.

2. The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated 1-10-2020 before the PIO requesting to furnish the information under Sec.6(1) of the RTI Act, 2005, on the following points mentioned in his application.

భారత రాజ్యాంగ సవరణ చేసి SC, ST ఉద్యోగులకు వియామకాల తో పాటు పదోన్నతులలో కూడా రిజర్వేషన్ లు కల్పించిన సంగతి తెలిసినదే.
నల్గొండ డిస్ట్రిక్ట్ బ్యాంక్ లో కేడర్ వారీగా నిర్వహిస్తున్న ప్రమోషన్ రోస్టర్ రిజిస్టర్ ల నకలు ప్రతి సెజ్ ద్రువీకరించి RTI చట్టం 2005 ప్రకారం ఇవ్వవలసిందిగా కోరుచున్నాను.
దరఖాస్తు ఫీజు రూపాయలు 10-00 (పది రూపాయలు మాత్రమే) కోర్ట్ ఫీజ్ స్టాంప్ రూపంలో చెల్లించటం జరిగింది.

3. The Public Information Officer has not furnished information to the Complainant.

4. As the Complainant did not receive the required information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

The Complaint was taken on file and notices were issued to the parties concerned for hearing on 13-06-2022.

On 13-06-2022 the case is called. The Complainant is absent. The Public Information Officer / Deputy General Manager, O/o the DCCB, Nalgonda is present.

The Public Information Officer submitted that vide letter No.Esst/RTI-2005/Vol-5/2020-21 dated 21-10-2020 informed the Complainant that the sought information could not be furnished to him. He further submitted that as per the Judgment passed by the Hon'ble Supreme Court in Civil Appeal No.9017 of 2013 as their organization will not come under "Public Authority" as defined in Sub-section(h) of Sec.(2) of RTI Act 2005. The burden is on the Complainant to establish it as a Public Authority.

In the instant case, the Complaint did not choose to attend the hearing nor filed affidavit offering his version to establish that it is a Public Authority.

Heard the Public Information Officer and perused the material papers available on record.

The Commission is of the view that the Public Information Officer has furnished factual status of the matter to the Complainant.

With the above observation, the Complaint is closed.
