ORDER

Sri SYED SAIFUDDIN QUADRI, R/o Hyderabad District has filed a Complaint dated 21-11-2020 which was received by this Commission on 23-11-2020 for not getting the information sought by him from the PIO / O/o The Telangana State Waqf Board, Razzak Manzil opp Public Garden, Nampally, Hyderabad.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated 24-09-2020 under Sec.6(1) of the RTI Act, 2005, before the PIO seeking following information:

1. Application of Shri Saifuddin Quadri date: 04-11-1997.
2. Wakf Office Proceeding H1/12/2/89, dated: 03-04-1998.
3. Report of inspection Committee, Dated: 10-09-1998.
4. Representation of Sri Syed Taj Uddin Quadri, dated: 21-09-1998.
5. Notification published in Siyasat New paper, dated: 09-10-1998.
6. Objection from V. Jagayya Sharma and Sri Shamsuddin Quadri dated: 22-10-1998.
7. Objection petition of Dr. Taj Uddin, dated: 21-10-1998.
8. Recommendation of Towliat Committee, dated: 07-11-1998.
9. wakf Board office proceeding of dated: 12-11-1998
10. Enquiry report submitted by EO dated: 16-08-1999.
11. Recommendation of Towliat Committee, dated: 29-9-1999.
12. Resolution of A.P. State of Wakf Board No.704/99, daed: 30-09-1999.

The PIO has not furnished the sought information to the complainant.

As the complainant did not receive the sought information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him.

The Complaint was taken on file and notices were issued to the parties concerned for hearing **on 19-04-2022**.

On 19-04-2022 the case is called. The Complainant is absent. The Public Information Officer, O/o the CEO, T.S.Wakq Board, Nampally, Hyderabad is absent.

The Public Information Officer filed a letter dated 18-4-2022 submitting that the staff of the entire Wakq Board are busy in duties for distribution of Gift packets to the Muslim community as ordered by the Government on the eve of Ramzan. Hence the Public Information Officer requested to adjourn the case after Ramzan.

In view of the above, the Complaint was **adjourned to 18-05-2022**.

On 18-05-2022 the case is called. The Complainant is absent. The Public Information Officer, O/o the Telangana State Wakq Board, Haj House, Nampally, Hyderabad is present.

The Public Information Officer submitted that the available information was furnished to the Complainant on 25-11-2020, 8-1-2021 and 16-05-2022.

The Complainant did not choose to attend the hearing nor filed affidavit offering his version.

Since available information is furnished, **the Complaint is closed.**
