ORDER

Sri K. VENKATA NARAYANA, R/o Warangal District filed 2nd appeal dated 23-11-2020 which was received by this Commission on 23-11-2020 for not getting the information sought by him from the PIO / O/o The Municipal Commissioner, Greater Warangal Municipal Corporation, Warangal District and 1st Appellate Authority / O/o The Municipal Commissioner, Greater Warangal Municipal Corporation, Warangal District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 02-12-2019 under Sec.6(1) of the RTI Act, 2005, before the PIO seeking the following information:

The Public Information Officer has not furnished the sought information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1st appeal dated 07-01-2020 before the 1st Appellate Authority requesting him to furnish the information sought.

As per the records enclosed it is noticed that the 1st Appellate Authority had failed to hear the case and pass appropriate orders on the 1st appeal filed before him.

As the appellant did not get information from the Public Information Officer, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him.

The 2nd Appeal was taken on file and notices were issued to the parties concerned for hearing on 30-06-2022.

On 30-06-2022 the case is called. The Appellant is absent. The Public Information Officer / Assistant City Planner, GWMC, Warangal is present. The 1st Appellate Authority is absent.

The Public Information Officer submitted that part information was furnished to the appellant on 6-3-2020. He has produced copy of information furnished to the appellant before the Commission along with dispatch proof.

The appellant did not choose to attend the hearing nor filed affidavit offering his version.

The Commission directs the Public Information Officer to furnish complete information to the appellant by RPAD within (15) days from the date of receipt of this order and submit compliance to the Commission.

With the above direction, **the Appeal is closed.**
