ORDER

Dr. V. Muralidhar Reddy, R/o. Warangal Urban District filed 2nd appeal dated 22-10-2019 which was received by this Commission on 23-10-2019 for not getting the information sought by him from the PIO / O/o. the District Collector, Warangal Urban District and 1st Appellate Authority / O/o. the District Collector, Warangal Urban District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 23-04-2019 under Sec.6(1) of the RTI Act, 2005, before the PIO seeking the following information:

Nageshwr Rao) గారు ఇచ్చిన తప్పుడు నివేదిక - రెవెన్యూ గురించి - ఘరియు ఘండల రెవిన్యూ అధికారులపై చట్ట ప్రాకారము తగు చర్యలు తీసుకొనుట - గురించి, ఇట్టి దరకాస్తులో ధర్మసాగర్ రెవిన్యూ అధికారుల తప్పిదల వలన సుమారు, 60,00,000/- విలువ గల భుమి మరియు రైతు బంధు, etc., నష్టము వటిల్లుతింది అని తగు చర్యలు తీసుకొమ్మని ధరకాస్తు ఇచ్చిఉన్నను,

- నేను తమ కార్యాలయము లో తేది 27/10/2018 రోజున ఇచ్చిన దరకాస్తు కాపీలను ద్రువీకరించి ఇవ్వగలరు
- అదేవిదముగా తమరు కాని తమ సిబ్బంది కాని ఇప్పటి వరకు నా యొక్క దరకాస్తులపై తీసుకొన్న చర్యలు వాటి వివరములు, అట్టి దరకాస్తు పై స్పందించి ధర్మసాగర్ రెవిన్యూ అధికారులకు ఇచ్చిన అదేశాల కాపీలు, వారి యొక్క సమదనములు, వాటి వివరములు పూర్తిగా ద్రువీకరించి ఇవ్వగలరు
- అదేవిదముగా తేది 28/01/2019 రోజున జిల్లా కార్యాలయము గ్రెవెన్సిల్ లో ఇచ్చిన దరకాస్తు కాపీలు వాటికి జత చేసిన దస్తవెజులు certify చేసిన కాపీలు, మరియు అట్టి దరకాస్తు పై తీసుకొన్న చర్యలు పూర్తిగా ద్రువీకరించి ఇవ్వగలరు.

The Public Information Officer has not furnished the sought information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1st appeal dated 21-05-2019 before the 1st Appellate Authority requesting him to furnish the information sought.

As per the records enclosed it is noticed that the 1st Appellate Authority had failed to hear the case and pass appropriate orders on the 1st appeal filed before him.

As the appellant did not get information from the Public Information Officer, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him.

The 2nd appeal was taken on file and notices were issued to both the parties for hearing on 05-07-2021.

On 05-07-2021 the case is called. The appellant is present. The PIO and the First Appellate Authority / O/o. the District Collector, Warangal Urban District filed letter of absence submitting that he is busy in "Palle Pragathi" Schedule. They authorized Smt. T.Vijaya Laxmi, Superintendent, C-Section, O/o. the District Collector, Warangal Urban District to present the case.

The representative of the PIO / O/o. the District Collector, Warangal Urban District filed affidavit of the PIO, wherein the PIO submitted that the sought information running into (75) pages was furnished to the appellant on payment of cost of Rs.150/- on 10-06-2019 which was acknowledged by him in person.

The appellant say that he is in physical possession of the land. The existing (4) shares in land was made into (8) shares illegally and submitted false report by Tahsildar to RDO who passed orders accepting the false report submitted by Tahsildar. Hence, he is seeking correction orders by the RDO.

The PIO / Naib Tahsildar, Dharmasagar Mandal submitted that the representation dated 27-10-2018 of the appellant could not be enquired due to pendency of case in Lok Ayukta in the same matter. He further submitted that he has filed detailed report before the Hon'ble Lok Ayukta and District Collector in the matter. In response to the representation dated 27-10-2018 furnished to him. He also submitted that a latest report has been sent to the RDO for taking further necessary action.

The contention of the appellant is that the RDO has issued orders on the false report submitted by the Tahsildar, Dharmasagar which resulted in loss of Rs.60,000/- to the appellant. He is seeking action taken report on his representation dated 27-10-2018 regarding action taken on the Tahsildar, Dharmasagar Mandal for giving false report leading to issue of orders by the RDO resulting in loss to him. The appellant submitted that he has not received information on his representation dated 27-10-2018.

In view of the above, the Commission directs the PIO / O/o. the District Collector, Warangal Urban District to furnish the factual status of matter on the representation of the appellant dated 27-10-2018 **within (15) days** and submit compliance to the Commission.

With the above direction, the Appeal was adjourned to 26-04-2022.

On 26-04-2022 the case is called. The Appellant is absent. The Public Information Officer / District Revenue Officer, Warangal Urban District is absent. The Administrative Officer is present on behalf of the Public Information Officer. The 1st Appellate Authority is absent.

This case was earlier heard on 05-07-2021 with a direction to the PIO / O/o. the District Collector, Warangal Urban District to furnish the latest status of matter on the representation dated 27-10-2018 within (15) days and submit compliance.

The appellant did not choose to attend the hearing nor filed affidavit offering his version.

The PIO submitted that in compliance with the direction of the Hon'ble Information Commission dated 05-07-2021 available detailed information was collected from 'D' Section which was submitted to the Hon'ble Lok Ayukta, Telangana State, Hyderabad. The same information running into (37) pages was furnished to the appellant and the Hon'ble Information Commission on 22-09-2021 by RPAD. As the matter is pending in Lok Ayukta, further action on the representation of the appellant dated 27-10-2018 can be taken as per outcome of the case in Hon'ble Lok Ayukta. He further submitted that the factual status of the matter submitted by the Tahsildar, Dharmasagar was furnished to the appellant vide letter No.C4/577/2022 dated 29-01-2022.

Heard the Public Information Officer and perused the records.

As per submission of the PIO, a case is pending before the Hon'ble Lok Ayukta, Hyderabad and a detailed factual report has been already submitted to the Hon'ble Lok Ayukta and a copy of the same is furnished to the appellant.

Since exhaustive information is furnished, the Appeal is **closed**.
