## **ORDER**

Sri D. ASHOK, R/o Nizamabad District filed 2<sup>nd</sup> appeal dated 20-11-2020 which was received by this Commission on 24-11-2020 for not getting the information sought by him from the PIO / O/o The Tahsildar, Parvathagiri Mandal, Warangal Rural District and 1<sup>st</sup> Appellate Authority / O/o The Revenue Divisional Officer, Warangal District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 21-05-2020 under Sec.6(1) of the RTI Act, 2005, before the PIO seeking the following information:

- 2) సర్కే నంబరు 535/A, 535/B/E, 536/C/2, 536/D/1, 538/B/4 & 536/C/1 సంబంధించిన 10207 సాదాజ్జేనామా సకళ్లు ధృవీకరించి ఇవ్వగలరు. విశుకల్ల శివారు.
- 1) సర్కే నంబర్లు విజిటి ఆర్డర్లు సంబంధించిన కేసు ఊరిలో సకళ్లు పత్రాలు ధృవీకరించి ఇవ్వగలరు.

The Public Information Officer has not furnished the sought information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1<sup>st</sup> appeal dated 06-07-2020 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought.

As per the records enclosed it is noticed that the 1<sup>st</sup> Appellate Authority had failed to hear the case and pass appropriate orders on the 1<sup>st</sup> appeal filed before him.

As the appellant did not get information from the Public Information Officer, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to arrange to furnish the information sought by him.

The 2<sup>nd</sup> Appeal was taken on file and notices were issued to the parties concerned for hearing on 15-06-2022.

On 15-06-2022 the case is called. The Appellant is absent. The Public Information Officer / Naib Tahsildar, Parvathagiri Mandal, Warangal Rural District is absent. The 1<sup>st</sup> Appellate Authority is absent.

The Public Information Officer has submitted a petition requesting to adjourn the case for some other date as he was under deputation to O/o the DSO, Warangal.

The record goes to show that the 6(1) application was filed on 29-05-2020 and the Public Information Officer has not furnished sought information to the appellant so far.

The Commission directs the Public Information Officer to furnish sought information to the appellant within (15) days from the date of receipt of this order and submit compliance to the Commission.

With the above direction, **the Appeal is adjourned** for compliance by the Public Information Officer.
