## <u>Order</u>

Sri B. Mahender has filed second appeal dated **29-08-2019** which was received by this Commission on **29-08-2019** for not getting the information sought by him from the Public Information Officer/ O/o the Gandhi Medical College, Hyderabad and the First Appellate Authority/ O/o the Osmania General Hospital, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **22-05-2019** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

(y postmorten Report of my Father

lete Sri B. Ram alander, who died on 27 0419.

(d) Name and designation of the police

officer who bad brought my father's

eliad body for conducting the postmorten

date and time of handing over the sead body

for conducting postmorten.

(3) Exact date and time of conducting the

postmorten and duration of time of

Conducting the postmorten.

More (3) points.

The Public Information Officer/ Gandhi Hospital, Secunderabad through Lr.Rc.No. 003912/GH/RTI/2019/1932 dated 10-06-2019 transferred the application under section 6(3) of RTI Act, 2005 to the Public Information Officer/ Gandhi Medical College, Secunderabad requested to provide information directly to the applicant by registered post under intimation to their office.

Stating that the appellant did not get any response from the Public Information Officer, he filed 1<sup>st</sup> appeal dated **24-07-2019** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate Authority, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, with a request to both the parties to attend for hearing on **20-04-2019 at 10.30 AM**.

The Case was heard on 20-04-2021. The appellant was absent. Sri. R.Shyam Sundar, OS, O/o. Gandhi Medical College, Secunderabad was present. The FAA/Dr.T.Sai Shobha, DCS.RMO, Osmania Hospital, Hyderabad was present and stated that a letter Rc.No.CSRMO/OGH/2019, dated.30-10-2019 they informed the appellant that information sought by him is a private hospital and it is not under the administrative control of them and hence requested the appellant to approach the hospital directly and seek the information. The PIO stated that vide letter Rc.No.RTI/GMC/2019/1047, dated.28-09-2019 the information sought by the appellant has been furnished through registered post. The PIO further submitted a copy of the information before the Commission.

Since the information is furnished, the appeal is closed.
