Order

Sri B. Mahender has filed second appeal dated **29-08-2019** which was received by this Commission on **29-08-2019** for not getting the information sought by him from the Public Information Officer/ O/o the KIMS., Secunderabad and the First Appellate Authority/ O/o the Osmania General Hospital, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **29-05-2019** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

- When did my father Late Sri B.Ramchander has been admitted in the hospital kindly furnish the exact date of admission, time, number of days treatment was given, and date of discharge and name of the attendant who admitted my father in the hospital, and on what reasons, furnish the complete information.
- Was there any injuries on any body parts at the time of admitting in the hospital, if yes, whether any complaint has been registered in the P.S and whether any MLC issued if yes please furnish the complete information.
- 3. Whether my father was suffering from multiple health related problems please furnish list of all the problems, whether he has been treated for the same and whether problems had been cured or not, please furnish the complete information along with the all medical reports and also furnish the name and designation of the duty doctor who attended.
- 4. Whether my father was having any symptoms of Alzheimer/dementia, if yes, any treatment has been give, and whether it has been cured or not, please furnish the complete report and also furnish the name and designation of the doctor who treated, and was it a common in aged persons.
- Whether my father was having any symptoms of shivering/tremor, if yes, any treatment has been given, and whether it has been cured or not, please furnish the complete report.
- Furnish the complete list of health related complications my father was suffering and what treatment has been given and whether he was responded to the treatment.
- Furnish the date and time of death and name of the person/persons who were present with my father at the time of death.
- 8. Whether any postmortem has been conducted or not.
- 9. Furnish the list of visitors from the date of admission till discharge.
- 10. Furnish the CCTV footage of from the date of admission till discharge ie., from 19-04-2019 to 27-04-2019.
- 11.List of all the documents/medical reports/death certificates issued and handed over to the attendant. Including the medical charges incurred if any for the treatment.

Stating that the appellant did not get any response from the Public Information Officer, he filed 1st appeal dated **24-07-2019** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate

Authority, he preferred this 2nd appeal before this Commission requesting to

arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

The Public Information Officer through Letter dated 17-01-2020 informed to

the Commission that the available information was already furnished to the

appellant on 03-12-2019.

In view of the above, with a request to both the parties to attend for hearing

on 07-04-2021 at 10.30 AM.

The Case was heard on 07-04-2021. The appellant was present and

submitted that the PIO has not furnished any information till date. The PIO/O/o.

the KIMS Hospital, Secunderabad was absent and the FAA/the Osmania General

Hospital, Afzalgunj, Hyderabad was also absent.

The Commission perused the material papers available on records and

observed that the appellant is seeking information from a private hospital i.e., from

O/o. the KIMS Hospital, Secunderabad and so vide letter dated.03-12-2019 the

Medical Superintendent has submitted a letter to the appellant stating that the

information has been furnished to the grandson of the patient but was returned

because of the wrong address.

The Commission advises the appellant to file a separate 6(1) application

before the PIO O/o. the Director of Medical Education, Hyderabad and seek the

information.

In view of the above, the appeal is closed.
