## **Order**

Sri S. Srinivas has filed second appeal dated **03-09-2019** which was received by this Commission on **04-09-2019** for not getting the information sought by him from the Public Information Officer/ The Assistant Director, O/o the ESIC Medical College, Sanathnagar, Hyderabad and the First Appellate Authority/ O/o the ESIC Medical College, Sanathnagar, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **20-07-2019** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

With reference to the subject above cited, the following information is required under Right to information act. Those who are attended the interview ON **03-07-2019** for the post of **SENIOR RESIDENT (CONTRACT) IN GENERAL SURGERY UNDER OBC** category.

- 3) No of candidates attended for interview for senior resident (Contract) under OBC on 03-07-2019.
- 4) Copies of all the member who are attended for interview under OBC for senior resident (Contract) post.
  - a) Academic performance (MBBS and other)
  - b) Board speciality
  - c) Distinction if anybody have and their details
  - d) Gold medal if any body have and their details
  - e) Experience if any body have and their details
  - f) Co-curricular, extension and professional development related activities if any body have and their details
  - g) Research and academic contributions if any body have and their details
  - h) NEET OPG-2019 and super speciality-2018) score and rank if anybody have so details.

The Public Information Officer through Lr.No. 799/Z/RTI/MCSNR/107/2019 dated 08-08-2019 furnished available information to the applicant.

Stating that the appellant was not satisfied with the reply of the Public Information Officer, he filed 1<sup>st</sup> appeal dated **16-08-2019** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

The First Appellate Authority through Lr.No. 799-Z/16/13/MC/2018 (RTI)-Admn dated 28-08-2019 informed to the appellant that the information sought by the appellant pertains to third party which cannot be disclosed without consent.

Stating that the appellant was not satisfied with the reply of the First Appellate Authority, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, with a request to both the parties to attend for hearing on **06-04-2021 at 10.30 AM.**

The Case was heard on 06-04-2021. The appellant was absent. The PIO/Sri.Samir Saurav, Assistant Director, O/o. ESIC Medical College, Sanathnagar, Hyderabad was present and the FAA/Dr.Kalyan Kumar Pal, Medical Superintendent, ESIC Medical College, Sanathnagar, Hyderabad was also present and vide letter No.799/Z/RTI/CSNR/101/2019 dated.24-03-2021 submitted before the Commission that the ESIC, Medical College Hospital, Sanathanagar, Hyderabad is functioning under ESIC is a statutory body under Ministry of Labour and Employment, Government of India. The PIO submitted that vide letter No.799/Z/RTI/MCSNR/107/2019, dated.08-08-2019 part information is furnished to the appellant through speed post and also vide letter letter No.799-Z/RTI/FAA/2018 dated.23-03-2021 the FAA has provided the available information to the appellant.

The Commission perused the material papers available on records and observed that the ESIC is a statutory body working under the Ministry of Labour and Employment, Government of India. Hence the Commission advises the appellant to file second appeal before the Central Information Commission and seek the information. Accordingly, the appeal is closed.
