## <u>Order</u>

Sri K.R. Rao has filed second appeal which was received by this Commission on **11-09-2019** for not getting the information sought by him from the Public Information Officer/ O/o the Deputy Commissioner, GHMC., Circle-20, Serilingampally, Ranga Reddy District and the First Appellate Authority/ O/o the Zonal Commissioner, Serilingampally Zone, Ranga Reddy District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **14-06-2019** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

The Public Information Officer through Letter dated 06-07-2019 furnished available information to the appellant.

Stating that the appellant was not satisfied with the reply of the Public Information Officer, he filed 1<sup>st</sup> appeal dated **22-07-2019** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate

Authority, he preferred this 2nd appeal before this Commission requesting to

arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, with a request to both the parties to attend for hearing

on 26-04-2021 at 10.30 AM.

The Case was heard on 26-04-2021. The appellant was absent. The PIO/

Sri.T.Vishal Kumar, Town Planning Supervisor, GHMC, Circle-20, Serilingampally

Zone was present and stated before the Commission that a letter RTI No./C-

20/110/2017/153, dated.06-07-2019 has been forwarded to the appellant stating

the information sought by him does not pertain to their office and the same is

available with the Head Office. The PIO further submitted a copy of the letter

before the Commission.

Heard the PIO and perused the material papers available on records. The PIO

instead of forwarding the letter to the appellant ought have forwarded the 6(1)

application to the concerned PIO u/s.6(3) of the RTI Act. The Commission took a

serious view against the PIO for not following the provisions of the RTI Act 2005

and warns the PIO not to repeat the same in the future.

The Commission directs the PIO to collect the information from the Head

Office and furnish the same to the appellant within 15 days from the date of

receipt of this order and to report compliance to the Commission.

With the above direction, the appeal is closed.
