## <u>Order</u>

Sri K.R. Rao has filed second appeal which was received by this Commission on **14-09-2019** for not getting the information sought by him from the Public Information Officer/ O/o the Deputy Commissioner, GHMC., Circle-20, Serilingampally, Ranga Reddy District and the First Appellate Authority/ O/o the Zonal Commissioner, Serilingampally Zone, Ranga Reddy District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **14-06-2019** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

Stating that the appellant did not get any response from the First Appellate Authority, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, with a request to both the parties to attend for hearing on **26-04-2021 at 10.30 AM**.

The case was heard on 26-04-2021. The appellant and the Public

Information Officer both are absent. Hence, the case is **adjourned**.

In view of the Covid-19 pandemic, with a request to both the parties to

attend for telephonic hearing on 23-06-2021 at 11.00 AM.

In view of the Covid -19 Pandemic, the case is heard over phone on

23-06-2021 with prior intimation to the concerned parties. The appellant did not

respond. The PIO / Sri.Mallaiah, Entamology Section, GHMC Circle - 20,

Serilingampally Zone responded and stated that the information sought by the

appellant has been furnished immediately after the telephonic notice from the

Commission and also submitted a copy of the endorsement.

The Commission took a series view for the delay caused in furnishing the

information to the appellant. The Commission warns the PIO tobe careful in future

and strictly adhere to the provisions of section 7(1) of the Act in furnishing the

information within 30 days from the date of filing 6(1) application.

Since the information is furnished, the appeal is closed.
