## Order

Sri K.R. Rao has filed second appeal which was received by this Commission on **14-09-2019** for not getting the information sought by him from the Public Information Officer/ O/o the Deputy Commissioner, GHMC., Circle-20, Serilingampally, Ranga Reddy District and the First Appellate Authority/ O/o the Zonal Commissioner, Serilingampally Zone, Ranga Reddy District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **14-06-2019** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

- ① ఈ కిక్విగా గాంధీ వారి శుశ్రూషా కమిటీ కు ఎంతమంది సభ్యులు ఉంటారు? వివరాలు తెలియజేయమని అడిగినందుకు ఐదేండ్లుగాగానూ సమాధానం ఇవ్వకుండా ఉంది. ESI & PF కేసులకు/ పాఠశాలల వారి వారి సభ్యులను వారి సలహా వేతనాల ఈ కుడిన కుడి వకతలు ఉంటాయి.
- ② స్టాఫ్ సోల్జుంగ్ కమిటీ కు ఎంతమంది సభ్యులు ఉంటారు? వీరినెవరు ESI/ PF కేసులకు సమాధానం ఇవ్వకుండా ఉంది.
- ③ వారి శుశ్రూషా కమిటీ కు ఎంతమంది ESI ఎన్నిసార్లు PF ఎన్నిసార్లు కేసులు ఉంటాయి. అలాగే అందులో వారి ESI ఎన్నిసార్లు PF ఎన్నిసార్లు కేసులు ఉంటాయి. ESI & PF కేసులకు అనుబంధంగా ఉన్న కేసులకు ఈ కుడిన కుడి వకతలు - అలాగే అవి ఎలా ఉంటాయి? ఉంటాయి, CD కు ఎంతమంది ఉంటారు.

Stating that the appellant did not get any response from the Public Information Officer, he filed 1<sup>st</sup> appeal dated **22-07-2019** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate Authority, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, with a request to both the parties to attend for hearing on **26-04-2021 at 10.30 AM.**

The case was heard on 26-04-2021. The appellant and the Public Information Officer both are absent. Hence, the case is **adjourned.**

In view of the Covid-19 pandemic, with a request to both the parties to attend for telephonic hearing on **23-06-2021 at 11.00 AM.** The appellant did not respond. The PIO / Sri.Ravi, Sanitation Section, GHMC, Circle -20, Serlingampally Zone has also not responded.

The Commission directs the PIO to furnish the information to the appellant by following the guidelines of section 8(1)(j) of the RTI Act, 2005 within one week through registered post with acknowledgement due and to report compliance to the Commission. The Commission also directs the PIO Sri. Ravi, Sanitation Section, O/o. GHMC, Circle -20, Serilingampally Zone to submit his explanation for not attending for telephone call for hearing from the Commission.

With the above direction, the complaint is closed.
