Order

Sri. Sambasivaw Rao has filed complaint dated **16-09-2019 & 10-11-2019** which was received by this Commission on **16-09-2019 & 11-11-2019** for not getting the information sought by him from the Public Information Officer/ The GM (P) RC, IR & PM, O/o the SCCL., Kothagudem, Bhadradri – Kothagudem District.

The brief facts of the case as per the Complaint and other records received along with it are that the complainant herein filed an application dated **15-09-2019** before the Public Information Officer requesting to furnish the information under Sec.6(1) of the RTI Act, 2005 on the following points mentioned:

- ① Refraco COP/DEPT IRPM/12081/1212 date 7-4-2019, with respect to R. Mallikarjuna COP ECHO 2593619 RYNT SRP, SCCL. List of panel specialist doctors, management of Anesthetist of Autoclaves and COP Medical Board to make fit and unfit, all reports, remedial records medical sheets. Taped copies sent certified copies to be sent to us. Application dt. 4-11-19 attended dt. 3-4-2021
- ② The 1-11-2006 to 30-9-2019, PRC, reports and EPR reports.
- ③ a) The all DICWA, local union agreements, all court orders, judgements, labor union affidavits, copies on dependent employment - baradar medical unit, death cases since 2000 to 30-9-19, pending petitions in court for dependent employment. b) Also send, on medical unit cases in SCV.
- ④ The list of dependents formed in SCV Service based on court order, based on medical unit, from SCV.
- ⑤ The total batonwala watchmen attended at CRB, list of unit and list batonwala, available, call letter, date, details in letter since 2000 to 30-9-19, reasons not to make unit above written VLS 4010
- ⑥ of RTI Act 2005 along with supporting documents of CRB be sent both in fact. Cont-20

The Public Information Officer through Ref. No. CRP/RTI-PIO/2907/750 dated 20-09-2019 requested the GM (P) RC, IR & PM and the CMO Main Hospital to furnish the information on priority as the information is sought under RTI Act, 2005 which is time bound, for onward submission to the applicant.

Stating that the complainant did not get any response from the Public Information Officer, he preferred this complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, with a request to both the parties to attend for hearing on **19-04-2021 at 10.30 AM.**

The Case was heard on 19-04-2021. The complainant was present and submitted that the PIO has not provided any information. The PIO/ Sri.D.Srinivas, Deputy General Manager(Personnel), O/o.SCCL, Kothagudem, Bhadradi Kothagudem District was present and stated before the Commission that the appellant is seeking personal information of a third party and vide letter Ref.No.CRP/RTI-PIO/2907/826, dated.12-10-2019 they have forwarded a letter to the appellant stating that the information sought pertains to personal information of the third party and it cannot be furnished as per section 8(1)(j) of the RTI Act 2005. The PIO further submitted a copy of the letter before the Commission.

Heard both the parties and perused the material papers available on records. The Commission observed that the complainant is seeking personal information of a third party and so it is exempted u/s.8(1)(j) of the RTI Act.

In view of the above, the complaint is closed.
