Order

Sri. Sambasivaw Rao has filed complaint dated **16-09-2019** which was received by this Commission on **16-09-2019** for not getting the information sought by him from the Public Information Officer/ The GM (PER), Welfare & CSR, O/o the SCCL., Kothagudem, Bhadradi – Kothagudem District.

The brief facts of the case as per the Complaint and other records received along with it are that the complainant herein filed an application dated **06-08-2019** before the Public Information Officer requesting to furnish the information under Sec.6(1) of the RTI Act, 2005 on the following points mentioned:

- ① In respect of Sr D. SAMBASIVARAO, ECONO. 2883705, by Supdt. U.A. Area Stn, SRP, SCCL referred on 30.4.2012.
- a) Contributory post-retirement Medicare scheme in non-Executive of SCCL - Circular copy, the amount to be paid at a time / installment to join in 2020 ~~2021~~ P.Y. calculation sheet to be sent, mode of payment, proforma, required documents to be submitted, at which ~~place~~, both the wife and Husband, the cashless payment Hospitals best in Hyd, TS, and in treatment in ID cards. The Total amount insured each, combined, life time, no of times, maximum amount can be in a year, in life time, each, combined can be. The insurance ID cards issued time and sent to us. The insured women go and admit directly in any Corp. Hospital or needed referral from SCCL Hospital. The Corp. Hospital admission be informed to user of Insurance Co. by us by admitted Hospital office daily informed.

More (4) points.

The Public Information Officer through Ref. No. CRP/RTI-PIO/2886/666 dated 13-08-2019 requested the GM(PER) Welfare & CSR, and the CMO Main Hospital to furnish the information on priority as the information is sought under RTI Act, 2005 which is time bound, for onward submission to the applicant.

Stating that the complainant did not get any response from the Public Information Officer, he preferred this complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, with a request to both the parties to attend for hearing on **19-04-2021 at 10.30 AM.**

The Case was heard on 19-04-2021. The complainant was present and submitted that the PIO has furnished the information but with long delay. The PIO/ Sri.D.Srinivas, Deputy General Manager(Personnel), O/o.SCCL, Kothagudem, Bhadradri Kothagudem District was present and stated before the Commission that vide letter Ref.No.CRP/RTI-PIO/2886/954, dated.15-11-2019 the information sought by the complainant is furnished through registered post. The PIO further submitted a copy of the information along with the copy of the acknowledgement.

Heard both the parties and perused the material papers available on records. The Commission observed that the PIO has furnished the information to the complainant.

Since the information is furnished, the complaint is closed.
