The Public Information Officer through Ref. No. CRP/RTI-PIO/2886/666 dated 13-08-2019 requested the GM(PER) Welfare & CSR, and the CMO Main Hospital to furnish the information on priority as the information is sought under RTI Act, 2005 which is time bound, for onward submission to the applicant.

Stating that the complainant did not get any response from the Public Information Officer, he preferred this complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, with a request to both the parties to attend for hearing on 19-04-2021 at 10.30 AM.

The Case was heard on 19-04-2021. The complainant was present and submitted that the PIO has furnished the information but with long delay. The PIO/ Sri.D.Srinivas, Deputy General Manager(Personnel), O/o.SCCL, Kothagudem, Bhadradri Kothagudem District was present and stated before the Commission that vide letter Ref.No.CRP/RTI-PIO/2886/954, dated.15-11-2019 the information sought by the complainant is furnished through registered post. The PIO further submitted a copy of the information along with the copy of the acknowledgement.

Heard both the parties and perused the material papers available on records. The Commission observed that the PIO has furnished the information to the complainant.

Since the information is furnished, the complaint is closed.
