## Order

Sri Sambasivaw Rao has filed second appeal dated **14-09-2019** which was received by this Commission on **16-09-2019** for not getting the information sought by him from the Public Information Officer/ The GM (PER) RC, IR & PM, O/o the SCCL., Kothagudem, Bhadradri – Kothagudem District and the First Appellate Authority/ O/o the SCCL., Kothagudem, Bhadradri – Kothagudem District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **03-06-2019** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

- ① The procedure, Company under no CRP/PER/IRPM/CIOS/CIOT Act, Govt judgements, on providing dependent employment to Central medical Board unit workmen of SCCL since 2-b-2014, copies must send to me.
  - ② The list of unit and fit workmen of CMB since 2-6-2014 issued order, copies workmen @ 1-25 to me, The reasons to make fit and unit by CMB U/S MO/CIOT RTI Act 2005.
  - ③ The full complete information of my three RTI Applications to your office on 11-9-2017 be sent immediately.
  - ④ The action taken report to stop medicals huge collected on this.
- Thanking you.

The Public Information Officer through Ref. No. CRP/RTI-PIO/2859/466 dated 11-06-2019 requested the GM(P) RC, IR & PM & the CMO Main Hospital to furnish the information on priority as the information is sought under RTI Act, 2005 which is time bound, for onward submission to the applicant.

Stating that the appellant was not satisfied with the reply of the Public Information Officer, he filed 1<sup>st</sup> appeal dated **05-08-2019** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the Public Information Officer and the First Appellate Authority, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, with a request to both the parties to attend for hearing on **19-04-2021 at 10.30 AM.**

The Case was heard on 19-04-2021. The appellant was present and submitted that the PIO has not provided any information. The PIO/ Sri.D.Srinivas, Deputy General Manager(Personnel), O/o.SCCL, Kothagudem, Bhadradi Kothagudem District was present and stated before the Commission that vide letter Ref.No.CRP/RTI-PIO/2859/676, dated.28-08-2019 the information sought by the appellant is furnished through registered post. The PIO further submitted a copy of the information along with the copy of the acknowledgement.

Heard both the parties and perused the material papers available on records. The Commission observed that the PIO has furnished the information to the appellant but the appellant claims that he has not received the information.

Hence the Commission directs the PIO to furnish the information once again to the appellant within one week through Registered post with acknowledgment due.

With the above direction, the appeal is closed.
