Order

Smt. K. Mukta Bai has filed complaint dated **18-09-2019** which was received by this Commission on **18-09-2019** for not getting the information sought by him from the Public Information Officer/ O/o the Dy. Commissioner, GHMC., Circle-21, Chandanagar, Ranga Reddy District.

The brief facts of the case as per the Complaint and other records received along with it are that the complainant herein filed an application dated **10-08-2019** before the Public Information Officer requesting to furnish the information under Sec.6(1) of the RTI Act, 2005 on the following points mentioned:

1. Please provide information along with one copy of all the relevant communication/documents regarding the steps/action taken by GHMC, Chandanagar subsequent to the inspection at site on 04-Apr-2019 (as detailed above) with regards to the building deviation by the builder/owner of Plot No.792/2 & 792/5 on the west side of his plot.
2. If no steps / action has been taken by GHMC, Chandanagar against the builder/owner of Plot No. 792/2 and 792/5 even after inspection on 04-Apr-2019, please provide relevant information along one copy of all the relevant communication/documents regarding why NO steps/action has been taken by GHMC, Chandanagar against the violators.
3. Please provide information along with one copy of all the relevant communication/documents regarding the steps/action taken by GHMC, Chandanagar subsequent to our application/complaint dated 22-Jul-2019 (as detailed above) with regards to the continued illegal construction by owner/builder of Plot No.792/2 and 792/5 and request for stopping construction and demolition of deviating portion.
4. If no steps / action has been taken by GHMC, Chandanagar against the builder/owner of Plot No. 792/2 and 792/5 even after our complaint on 22-Jul-2019, please provide relevant information along one copy of all the relevant communication/documents regarding why NO steps/action has been taken by GHMC, Chandanagar against the violators.

Stating that the complainant did not get any response from the Public Information Officer, she preferred this complaint before the Commission requesting to arrange to furnish the information sought by her u/s 18(1) of the RTI Act, 2005.

In view of the above, with a request to both the parties to attend for hearing on **26-04-2021 at 10.30 AM.**

The Case was heard on 26-04-2021. The complainant was present and stated that the PIO has not provided relevant information. The PIO/ Sri.P.Madhu, Town Planning Supervisor, GHMC, Circle-21, Chanda Nagar, Rangareddy District was present and stated before the Commission that vide letter Lr.No.RTI/116/TPS/Cir-21/2019, dated.13-08-2019 the information sought by the complainant has been furnished through registered post. The PIO further submitted a copy of the information before the Commission.

Heard both the parties and perused the material papers available on records. The Commission observed that the PIO has furnished the information to the complainant but the complainant claims that he has not received the information relating to the action taken report on the legal deviation taken place which he sought through his 6(1) application.

Hence the Commission directs the PIO to furnish the complete information once again to the complainant within one week through RPAD and to report compliance to the Commission.

With the above direction, the appeal is closed.
