Order

Sri B. Mahender has filed complaint dated **19-09-2019** which was received by this Commission on **19-09-2019** for not getting the information sought by him from the Public Information Officer/ O/o the Gandhi Medical College, Hyderabad.

The brief facts of the case as per the Complaint and other records received along with it are that the complainant herein filed an application dated **22-05-2019** before the Public Information Officer requesting to furnish the information under Sec.6(1) of the RTI Act, 2005 on the following points mentioned:

- (1) Postmortem Report of my Father...
Late. Sri. B. Ramchander, who died on 27-04-19.
- (2) Name and designation of the Police Officer who had brought my father's dead body for conducting the postmortem, date and time of handing over the dead body for conducting postmortem.
- (3) Exact date and time of conducting the postmortem and duration of time of conducting the postmortem.

The Public Information Officer through Lr.Rc.No. RTI/GMC/2019/1047 dated 28-09-2019 furnished available information to the complainant.

Stating that the complainant was not satisfied with the reply of the Public Information Officer, he preferred this complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

The Public Information Officer through Lr.Rc.No. RTI/GMC/2021/291 dated 08-04-2021 informed to the Commission that the available information was already furnished to the complainant on 28-09-2019.

In view of the above, with a request to both the parties to attend for hearing on **20-04-2021 at 10.30 AM.**

The Case was heard on 20-04-2021. The appellant was absent. Sri. R.Shyam Sundar, OS, O/o. Gandhi Medical College, Secunderabad was present and stated that vide letter Rc.No.GMC/2019/1047, dated.28-09-2019 the information sought by the complainant has been furnished through registered post. The PIO further submitted a copy of the information before the Commission.

Heard the PIO and perused the material papers available on records. The Commission observed that PIO has furnished the information to the complainant.

Since the information is furnished, the complaint is closed.
