## **Order**

Sri V. Ramesh Goud has filed complaint dated **18-09-2019** which was received by this Commission on **19-09-2019** for not getting the information sought by him from the Public Information Officer/ O/o the DM&HO., Suryapet District.

The brief facts of the case as per the Complaint and other records received along with it are that the complainant herein filed an application dated **20-07-2019** before the Public Information Officer requesting to furnish the information under Sec.6(1) of the RTI Act, 2005 on the following points mentioned:

1) రెండు కేసుల పట్ల సమాచారం తెలియజేయమని ప్రార్థన చేసినప్పటికీ, అందుకు సంబంధించిన సమాచారం అందుకోలేకపోయాను.

2) కేసు నంబర్లు, కేసులకు సంబంధించిన అధికారి పేర్లు, ఫిర్యాదులకు సంబంధించిన సమాచారం తెలియజేయమని ప్రార్థన చేసినప్పటికీ, అందుకు సంబంధించిన సమాచారం అందుకోలేకపోయాను.

3) ప్రస్తుత వివాదానికి సంబంధించిన కేసులకు సంబంధించిన అధికారి పేర్లు తెలియజేయమని ప్రార్థన చేసినప్పటికీ, అందుకు సంబంధించిన సమాచారం అందుకోలేకపోయాను.

The Public Information Officer through Lr.No. 1631/E2/2019 dated 21-08-2019 furnished available information to the complainant.

Stating that the complainant was not satisfied with the reply of the Public Information Officer, he preferred this complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, with a request to both the parties to attend for hearing on **10-02-2021 at 10.30 AM.**

The case was heard on 10-02-2021. The complainant was absent. The Public Information Officer was present. The Commission directs the Public Information Officer to gather the information from the concerned office and furnish the same to the complainant within two weeks and to report compliance to the Commission and hence the case is **adjourned.**

In view of the above, with a request to both the parties to attend for hearing on **20-04-2021 at 10.30 AM.**

The Case was heard on 20-04-2021. The complainant was absent. The PIO/Dr.B,Srinivasa Raju, Administrative Officer(I/c.), O/o. DMHO, Suryapet District was present and stated before the Commission that vide letter No.545/A3/2021, dated.15-04-2021 the information sought by the complainant was furnished through registered post. The PIO further submitted a copy of the information along with the copy of the postal receipt as a proof of dispatch.

The Commission perused the material papers available on records and observed that the PIO has furnished the information to the complainant.

Since the information is furnished, the complainant is closed.
