## Order

Sri K.R. Rao has filed second appeal which was received by this Commission on **26-09-2019** for not getting the information sought by him from the Public Information Officer/ O/o the Deputy Commissioner, GHMC., Circle-21, Chandanagar, Ranga Reddy District and the First Appellate Authority/ O/o the Zonal Commissioner, Serilingampally Zone, Ranga Reddy District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **14-06-2019** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

The Public Information Officer through Lr.No. 1110/Chandanagar, Circle-21/GHMC/2019 dated 08-07-2019 furnished available information to the appellant.

Stating that the appellant was not satisfied with the reply of the Public Information Officer, he filed 1<sup>st</sup> appeal dated **22-07-2019** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate Authority, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to

arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, with a request to both the parties to attend for hearing

on **26-04-2021** at **10.30** AM.

The Case was heard on 26-04-2021. The appellant was absent. The PIO/ Sri.P.Madhu, Town Planning Supervisor, GHMC, Circle-21, Chanda Nagar, Rangareddy District was present and stated before the Commission that the appellant is seeking third party information and hence they did not furnish the

information to the appellant.

Heard the PIO and perused the material papers available on records. The Commission observed that the appellant for some points in his 6(1) application is

seeking personal information.

Therefore the commission directs the PIO to furnish the remaining information to the appellant except for personal information as per section 8(1)(j) of the RTI Act within one week through registered post with acknowledgement due

and to report compliance to the Commission.

With the above direction, the complaint is closed.
