## **Order**

Sri M.S. Vijaya Prasad has filed second appeal dated **30-09-2019** which was received by this Commission on **30-09-2019** for not getting the information sought by him from the Public Information Officer/ O/o the Deputy Commissioner, GHMC., Circle-21, Chandanagar, Ranga Reddy District and the First Appellate Authority/ O/o the Zonal Commissioner, Serilingampally Zone, Ranga Reddy District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **06-07-2019** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

- 1) ***As per records the identity details of officer/ operator responsible for allocating/ posting to the online web site, the PTI No. 1219973539 and (6) more points.***

The Public Information Officer through Lr.No.RTI/100/TPS/Cir-21/2019 dated 31-07-2019 furnished available information to the appellant.

Stating that the appellant was not satisfied with the reply of the Public Information Officer, he filed 1<sup>st</sup> appeal dated **09-08-2019** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

The First Appellate Authority through Notice Case No. 1252/RTI/ZC/SLPZ/GHMC/2019 dated 22-08-2019 directed the Public Information Officer and the appellant to appear for hearing on 16-09-2019 @ 3.00 PM along with related records/ documents.

The Public Information Officer through Lr.No. RTI/C-21/171/2019 dated 17-09-2019 furnished available information to the appellant.

The First Appellate Authority through Order Case No. 1252/ZC/SLPZ/GHMC/2019 dated 20-09-2019 informed that the Assistant Public Information Officer has furnished the information to the appellant on 09-2019. The First Appellate Authority has acknowledged the same and directed to close the appeal.

Stating that the appellant was not satisfied with the reply of the First Appellate Authority, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, with a request to both the parties to attend for hearing on **26-04-2021 at 10.30 AM.**

The Case was heard on 26-04-2021. The complainant was present and stated that the PIO has not provided him proper information. The PIO/ Sri.P.Madhu, Town Planning Supervisor, GHMC, Circle-21, Chanda Nagar, Rangareddy District was present and stated before the Commission that the information sought by the complainant is not specific and also vide letter No.RTI/100/TPS/Cir-21/2019, dated.31-07-2019 they have informed the complainant to provide the specific file number so that they can trace out the information. The PIO further submitted a copy of the letter before the Commission.

Heard both the parties and perused the material papers available on records. The Commission observed that the PIO ought to have provided details relating to the concerned PTI Numbers to the complainant instead of stating that they were unable to trace out the information. The Commission warns the PIO not repeat the same in the future.

Therefore the Commission directs the PIO to furnish the complete report of the information sought by the complainant through his 6(1) application dated. 06-07-2019 within one week from the date of receipt of this order through RPAD and to report compliance to the Commission. In case the PIO fails to comply with the instructions issued, action will be taken against the PIO as per Section 20 of the RTI Act 2005.

With the above direction, the complaint is closed.
