Order

Sri. Sambasivaw Rao has filed complaint dated **29-09-2019** which was received by this Commission on **30-09-2019** for not getting the information sought by him from the Public Information Officer/ The GM (PER), Welfare & CSR, O/o the SCCL., Kothagudem, Bhadradri – Kothagudem District.

The brief facts of the case as per the Complaint and other records received along with it are that the complainant herein filed an application dated **05-08-2019** before the Public Information Officer requesting to furnish the information under Sec.6(1) of the RTI Act, 2005 on the following points mentioned:

- 1) Ref.No. CRP/PER/IRPH/C/021/1218 date 7.4.2015 in respect of SMC V. Sheopathi, TM, PANT, SCNO 2518887, SCCL - the list of panel of Specialist Doctors examined at Area Medical Authorities and Govt Medical School to make Fit & unfit, all reports, remedies, recorded medical sheets Typed Copies vests certification be sent to us.
- 2) the last 19 years PHE reports and TB Sanctioned and paid order and payments details, unfit and Fit Certificate
- 3) the dependent employment to medical institutions, accounts of NCUA and local union adveements, CIO/IS permit, Co and High courts, and order dated 16.3.2017 by WJ (PIL) no. 194 2017. dependent age limit and ex-servicemen age limit for workmen of SCCL, PNH, PNH 508 based on Qualification, all copies certification send Ref No CRP/PER/IR/021/305 dt 9.3.2019
- 4) The total workmen made Fit and unfit & taken work. Since 21.6.2014 to as on today by CM B. The total dependent were appointed as SCCL. Reasons refused until 15.11.2018 & 17.10.2018

More (4) points.

The Public Information Officer through Ref.No. CRP/RTI-PIO/2887/667 dated 13-08-2019 requested the GM (PER) Welfare & CSR/GM (P) RC, IR & PM and the CMO Main Hospital to furnish the information on priority as the information is sought under RTI Act, 2005 which is time bound, for onward submission to the applicant.

Stating that the complainant was not satisfied with the reply of the Public Information Officer, he preferred this complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, with a request to both the parties to attend for hearing on **19-04-2021 at 10.30 AM.**

The Case was heard on 19-04-2021. The complainant was present and submitted that the PIO has not provided any information. The PIO/ Sri.D.Srinivas, Deputy General Manager(Personnel), O/o.SCCL, Kothagudem, Bhadradi Kothagudem District was present and stated before the Commission that the appellant is seeking personal information of a third party and vide letter Ref.No.CRP/RTI-PIO/2887/922, dated.07-11-2019 and they have forwarded a letter to the appellant stating that the information sought pertains to personal information of the third party and it cannot be furnished as per section 8(1)(j) of the RTI Act 2005. The PIO further submitted a copy of the letter before the Commission.

Heard both the parties and perused the material papers available on records. The Commission observed that the complainant is seeking personal information of a third party and so it is exempted u/s.8(1)(j) of the RTI Act.

In view of the above, the complaint is closed.
