## Order

Sri. Sambasivaw Rao has filed complaint dated **30-09-2019** which was received by this Commission on **30-09-2019** for not getting the information sought by him from the Public Information Officer/ The GM (PER), RC, IR & PM, O/o the SCCL., Kothagudem, Bhadradri – Kothagudem District.

The brief facts of the case as per the Complaint and other records received along with it are that the complainant herein filed an application dated **12-08-2019** before the Public Information Officer requesting to furnish the information under Sec.6(1) of the RTI Act, 2005 on the following points mentioned:

- ① Ref. no. CRP/PER/IRPM/CL081/1218 date 7-4-2015 in respect of Sri. Huppu Barkar, Tramma, E.C.No. 2816334, R.KONT, SRP. The list of panel of specialist doctors examined at Area Medical Authority and Corp. Medical Board to make Fit and unfit, all reports, remarks, records, medical sheets typed copies with certification he sent to us with application dt. 8-7-19 in C.M.B. attendance 29/1/2019..
- ② The last 19 years PTE reports and EPR records.
- ③ The independent employment to medical unit of ANU and local union agreements, CIO/TS promise, Gov and High Court, Hud sides, dated 16-3-2017 in WP (PIL) NO. 199/2017. dependent age limit and ex-servicemen age limit of ex-women of SCCL, Health, female job based on Diabetic cases, all copies certified copies send, Ref. no. CRP/PER/IR/CL081/305 dt. 9-3-2018. Recent court order dt. 14-9-2019. The total women made unit and fit batchwise at Area Medical Authority and at Corp. Medical Board since 2001 to as on today.
- ④ The reasons to refuse unit the donee services us 2001(d) 1 RTI Act-2005 must be send.

### **More (4) points.**

The Public Information Officer through Ref.No. CRP/RTI-PIO/2898/708 dated 02-09-2019 requested the GM(P) RC, IR & PM and the CMO Main Hospital to furnish the information on priority as the information is sought under RTI Act, 2005 which is time bound, for onward submission to the applicant.

Stating that the complainant was not satisfied with the reply of the Public Information Officer, he preferred this complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, with a request to both the parties to attend for hearing on **19-04-2021 at 10.30 AM.**

The Case was heard on 19-04-2021. The complainant was present and submitted that the PIO has not provided any information. The PIO/ Sri.D.Srinivas, Deputy General Manager(Personnel), O/o.SCCL, Kothagudem, Bhadradi Kothagudem District was present and stated before the Commission that for some points through his 6(1) application the complainant is seeking personal information of a third party and is exempted as per section 8(1)(j) of the RTI Act 2005 and vide letter Ref.No.CRP/RTI-PIO/2898/829, dated.12-10-2019 they informed the same to the complainant and also vide letter Ref.No.CRP/RTI-PIO/2898/723, dated. 16-09-2019 the remaining information was furnished to the complainant. The PIO further submitted a copy of the information before the Commission.

Heard both the parties and perused the material papers available on records. The Commission observed that the PIO has furnished the available information to the complainant.

Since the information is furnished, the complaint is closed.
