## <u>Order</u>

Sri Fakhruddin has filed complaint dated **24-08-2018** which was received by this Commission on **25-08-2018** for not getting the information sought by him from the Public Information Officer/ O/o the Shadan Intitute of Medical Sciences, Chevella Road, Himayat Sagar, Peerancheru, Hyderabad.

The brief facts of the case as per the Complaint and other records received along with it are that the complainant herein filed an application dated **09-07-2018** before the Public Information Officer requesting to furnish the information under Sec.6(1) of the RTI Act, 2005 on the following points mentioned:

- Kindly let me know do Shadan Hospital know about Physiotherapist Mohd Amjad(9966959983) indulges in Act of cheating(IPC 420) and criminal Intimidation(IPC 506) in FIR No.189/2018 at Golconda PS. Considering answer is yes, A kindly attach number staff member of Shadan Hosipital indulges/alleged/undergoing trail in courts
- 2. Kindly give information on what act of IPC other staff are indulge in.
- 3. What action do management take on criminal Alleged/Indulge/Convicted accused from their end on such persons

Stating that the complainant did not received the sought information from the Public Information Officer, he preferred this complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the complaint may be taken on file and notices issued to both the parties for hearing on <u>25-11-2020 at 11.00 AM</u>.

The Case was heard on 06-04-2021. The appellant was absent. The PIO/O/o. the Shadan Institute of Medical Sciences, Patancheru, Hyderabad was also absent.

The Commission directs the PIO to furnish the information to the complainant within one week through registered post with acknowledgment due and to report compliance to the Commission.

With the above direction, the complaint is closed.
