## <u>Order</u>

Sri Ch. V. Narsing Rao has filed complaint dated **17-10-2019** which was received by this Commission on **17-10-2019** for not getting the information sought by him from the Public Information Officer/ O/o the Dy. Commissioner, GHMC., Serilingampally, Ranga Reddy District.

The brief facts of the case as per the Complaint and other records received along with it are that the complainant herein filed an application dated **16-07-2019** before the Public Information Officer requesting to furnish the information under Sec.6(1) of the RTI Act, 2005 on the following points mentioned:

I request you sir, to kindly provide the information relating to building permit No.3/C20/12489/2018, dt. 27.07.2018 (File No.3/C11/06891/2018) of Smt. Leeladevi & Others, R/o 8-3-230/C/45/1, Venkatagiri, Yousufguda, Hyderabad, and LRS and proceedings/NOC issued by the ULC wing of the office of the District Collector, Ranga Reddy District available with you in respect of Plot No: 109/Bin survey No: 77 at Raghavendra Nagar Colony, Kondapur under RTI Act, as the information is very much required by me and I will bear the necessary expenses to furnish the information to me. I will take the copies personally from your office.

The Public Information Officer through Letter dated 28-08-2019 informed to the complainant that he was seeking third party information. However, the same information will be furnished after receiving the third party consent.

The Public Information Officer through Letter dated 14-09-2019 informed to the complainant that the information sought by him pertains to third party cannot be furnished.

Stating that the complainant was not satisfied with the reply of the Public Information Officer, he preferred this complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, with a request to both the parties to attend for hearing on **27-04-2021 at 10.30 AM.** 

The Case was heard on 27-04-2021. The complainant is absent. The PIO/Sri.A.Balraj, Superintendent, GHMC, Circle – 20, Serilingampally Zone is present and stated that the appellant is seeking third party information and vide letter No.RTI/C20/141/2019, dated.28-08-2019 they have informed the appellant that as per Section 11(1) of the RTI Act 2005 a letter was forwarded to the third party seeking his consent whether to furnish his information sought by the complaint. The PIO further submitted that the third party vide his letter dated.13-09-2019 has refused to furnish his personal documents to the complainant.

The Commission directs the PIO to furnish the information following the guidelines of section 8(1)(j) of the RTI Act within one week through registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the compliant is closed.
