Order

Sri. Sambasivaw Rao has filed complaint dated **28-10-2019** which was received by this Commission on **29-10-2019** for not getting the information sought by him from the Public Information Officer/ O/o the SCCL., Kothagudem, Bhadradri – Kothagudem District.

The brief facts of the case as per the Complaint and other records received along with it are that the complainant herein filed an application dated **16-09-2019** before the Public Information Officer requesting to furnish the information under Sec.6(1) of the RTI Act, 2005 on the following points mentioned:

Padmalathic, 39 years as on 25.2.2000, report remarks and final order of the Competent Committee regarding the procedure and provisions to re-examine at SCCL and to apply to Appellate Medical Authority at Hyderabad against SCCL Medical authority of Hyderabad.

Stating that the complainant did not get any response from the Public Information Officer, he preferred this complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, with a request to both the parties to attend for hearing on **19-04-2021 at 10.30 AM.**

The Case was heard on 19-04-2021. The complainant was present and submitted that the PIO has not furnished the information. The PIO/ Sri.D.Srinivas, Deputy General Manager(Personnel), O/o.SCCL, Kothagudem, Bhadradri Kothagudem District was present and stated before the Commission that vide letter Ref.No.CRP/RTI-PIO/2909/825, dated. 12-10-2019 the information sought by the complainant is furnished through registered post. The PIO further submitted a copy of the information along with the copy of the acknowledgement.

Heard both the parties and perused the material papers available on records. The Commission observed that the PIO has furnished the information to the complainant.

Since the information is furnished, the complaint is closed.
