## Order

Sri Ch. Ratan Kalyan has filed second appeal dated **28-10-2019** which was received by this Commission on **29-10-2019** for not getting the information sought by him from the Public Information Officer/ O/o the Deputy Commissioner, GHMC., Circle-20, Serilingampally, Ranga Reddy District and the First Appellate Authority/ O/o the Zonal Commissioner, Serilingampally Zone, Ranga Reddy District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **18-03-2019** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

Furnish on what basis and right you have changed and issued the property tax receipt in the name of Mr. Mohd. Ghouse. Please furnish the documents filed for change of name, if any.

Stating that the appellant did not get any response from the Public Information Officer, he filed 1<sup>st</sup> appeal dated **11-05-2019** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate Authority, he preferred this  $2^{nd}$  appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, with a request to both the parties to attend for hearing on **26-04-2021 at 10.30 AM**.

The case was heard on 26-04-2021. The appellant and the Public Information Officer both are absent. Hence, the case is **adjourned**.

In view of the Covid-19 pandemic, with a request to both the parties to attend for telephonic hearing on **23-06-2021 at 11.00 AM.** The appellant responded and stated that the PIO has not provided the information. The PIO /Sri.Balraj, Superintendent, GHMC, Circle 20, Serilingampally Zone has not responded and Sri. Venkanna, Deputy Commissioner, Circle 20, Serilingampally Zone has also not responded.

The Commission perused the material papers available on records and observed that the PIO has not furnished the information to the appellant till the date of hearing and also not responded to the telephonic call even after the receipt of Mail & SMS from this Commission. The Commission thereby directs to issue **Show Cause Notice** to the PIO Sri Balraj, Superintendent, GHMC Circle 20, Serilingampally Zone and Sri.Venkanna, Deputy Commissioner, Serilingampally Zone for not furnishing information to the appellant and also for not attending the telephonic call for hearing from the Commission.

The Commission also directs the PIO to furnish the information to the appellant within one week through RPAD. The order on **Show Cause Notice** will be dealt separately.

With the above direction, the appeal is closed.
