

## **Order**

Sri M. Muthyalu Goud has filed complaint dated **01-11-2019** which was received by this Commission on **01-11-2019** for not getting the information sought by him from the Public Information Officer/ District Revenue Officer, Medchal – Malkajgiri District.

The brief facts of the case as per the Complaint and other records received along with it are that the complainant herein filed an application dated **26-08-2019** before the Public Information Officer requesting to furnish the information under Sec.6(1) of the RTI Act, 2005 on the following points mentioned:



Stating that the complainant did not get any response from the Public Information Officer, he preferred this complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the Covid-19 pandemic, with a request to both the parties to attend for telephonic hearing on **16-06-2021 at 11.00 AM.**

In view of the Covid -19 Pandemic, the case is heard over phone on 16-06-2021 with prior intimation to the concerned parties. The complainant

responded and stated that the PIO has not provided him information. Smt.Swetha,

Junior Assistant, O/o. District Panchayat Officer, Medchal Malkajgiri District responded and stated that the PIO/O/o. The District Revenue Office, Medchal

Malkajgiri District has transferred the 6(1) application filed by the complainant

U/s.6(3) of the RTI Act 2005 to the PIO/O/o.the District Officer, Medchal

Malkajgiri District. The PIO further submitted that the information sought by the

complainant is furnished in the 2019 but failed to provide the copy of the

information furnished.

The Commission perused the material papers available on records and

observed that the PIO has not furnished the information to the complainant. The

Commission took a series view for not furnishing the information to the

complainant and warns the PIO tobe careful in future and strictly adhere to the

provisions of section 7(1) of the Act in furnishing the information within 30 days

from the date of filing 6(1) application.

The Commission directs the PIO to furnish the information to the appellant

within one week through RPAD and report compliance to the Commission on

13-07-2021. If the PIO fails to comply with the instructions issued, action will be

taken against the PIO as per section 20 of the RTI Act, 2005.

With the above direction, the complaint is closed.
