Order

Sri Md. Ashraf Ali has filed second appeal dated **04-05-2019** which was received by this Commission on **05-11-2019** for not getting the information sought by him from the Public Information Officer/ The Deputy GM, O/o the SCCL., Srirampur, Bhadradri – Kothagudem District and the First Appellate Authority/ O/ o the GM, SCCL., Srirampur, Bhadradri – Kothagudem District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **04-05-2019** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

- 1) On 27-Oct-2017 Mr. Madar Sab was involved in theft case (FIR# 244/2018) as A2 accused and kidnap case (FIR# 743/2017) A1 accused in Hyderabad. I came to know that during service he got jailed in Golden Forest scam, does it was recorded by SCCL management
- 2) What was the Designation and department in which Shri Madar Sab is posted. { disclosure of such information to public should be made as per RTI act 2005 under section 4(1)(b)}
- 3) The power and duties/job responsibility/work profile of Madar Sab. {disclosure of such information to public should be made as per RTI act 2005 under section 4(1)(b)}
- 4) Annual property returns filed by him till date. { Relevant decision of CIC dated 31 March,2018 No.CIC/OK/A/2007/01493 & CIC/OK/A/2008/00027 regarding providing such information to public is attached for ready reference}
- 5) Provide the service book record of Shri Madar Sab { Disclosure of such information does not come under 3rd Party as per CIC order Dated 13th may 2013 - CIC/AD/A/2012/002874}
- 6) Present pension amount he getting and its various components like basic pay, DA, Conveyance, HRA and other allowances of Shri Madar Sab. { disclosure of such information to public should be made as per RTI act 2005 under section 4(1)(b)}
- 7) Photo copy and details of his educational/professional qualification and his bio data and age proof (like certificate of 10th or any other proof) on the basis of which he is holding a public office in RBI. {Latest relevant decision of CIC dated 10 feb,2009 No.CIC/SG/A/2008/00248/1596 regarding providing such information to public is attached for ready reference}
- 8) Has there been any disciplinary action, criminal cases against him
- 9) Has Shri Madar Sab declared No Dowry declaration form any financial year
- 10) How many times he got suspended from duty and reason for such suspension
- 11) If SCCL employee got involved into crime, is there any actions will take by SCCL management
- 12) How many absented during service & cause for absents.
- 13) Please provide me the leave details
- 14) On what basis he got promotions during service.
- 15) When he got retired from the services
- 16) How much he got from retirement benefits

The Public Information Officer through Ref No. CRP/RTI-PIO/392 dated 11-05-2019 transferred the application under section 6(3) of RTI Act, 2005 to the DGM (P) & PIO:SRP AREA and requested them to furnish the required information to the applicant directly under intimation to their office.

The Public Information Officer through Ref.No. SRP/PER/RTI/25.000/5225 dated 20-08-2019 informed to the appellant that the information asked is the personal information of the third party and it cannot be furnished as per section 8(1)(j) of the RTI Act, 2005.

Stating that the appellant was not satisfied with the reply of the Public Information Officer, he filed 1st appeal dated **03-09-2019** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

The First Appellate Authority through Order dated 18-09-2019 informed that the information sought by the applicant is third party information which is exempted under section 8(1)(j) of RTI Act, 2005 and it seems that there is no public interest.

Stating that the appellant was not satisfied with the reply of the Public Information Officer and the First Appellate Authority, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, with a request to both the parties to attend for hearing on **19-04-2021 at 10.30 AM.**

The Case was heard on 19-04-2021. The appellant was absent. The PIO/Sri.B.Nicholas, Deputy General Manager(Personnel), O/o.SCCL, Srirampur, Mancherial District was present and stated before the Commission that the appellant is seeking personal information of an employee who worked in SCCL and vide letter Ref.No.SRP/PER/RTI/25.000/5225, dated.19/22-08-2019 they have forwarded a letter to the appellant stating that the information sought is the personal information of the third party and it cannot be furnished as per section 8(1)(j) of the RTI Act 2005. The PIO further submitted a copy of the letter before the Commission.

Heard the PIO and perused the material papers available on records. The Commission observed that the appellant is seeking personal information of a third party and so it is exempted u/s.8(1)(j) of the RTI Act.

In view of the above, the appeal is closed.
